WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **Three Hundred Sixty Five Thousand and 00/100 Dollars (\$365,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Freddy J. Rains aka Fred J. Rains, an unmarried person, by and through his Attorney-in-Fact, Mary R. Rains, and Mary R. Rains aka Mary S. Rains, an unmarried person

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Jon Brody Black and Gidge Glaze Black

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 8, Second Sector, according to the Survey of Altadena Woods Subdivision, Second and Fifth Sectors, as recorded in Map Book 10, Page 54 A & B, in the Probate Office of Shelby County, Alabama; and in Map Book 151, Page 25 in the Probate Office of Jefferson County, Alabama; being situated in Shelby County, Alabama.



\$232,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

And we do for ourselves and for our heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.
