
**\$270,750.00** of the proceeds come from a mortgage recorded simultaneously herewith.



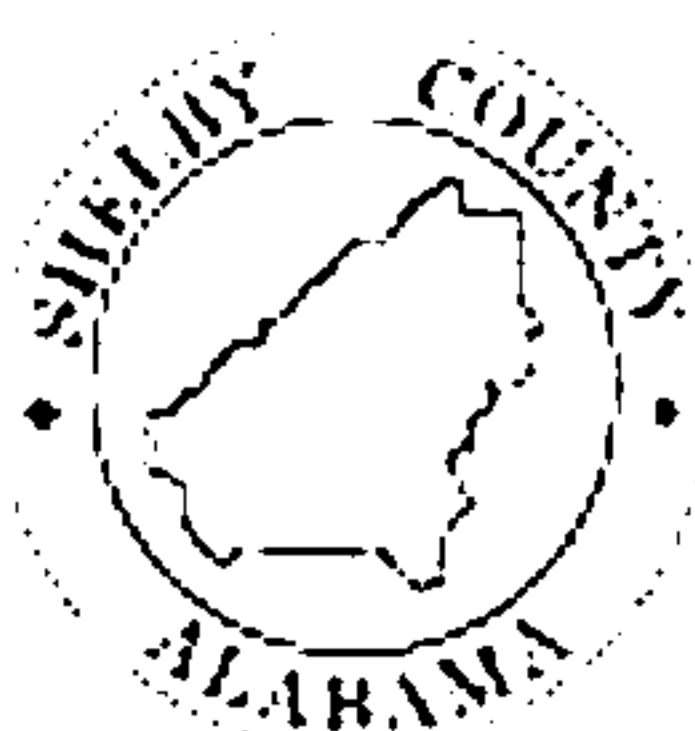
