FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of March, 2003, Rockford Wright, a married person and Denise L Wright, a married person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for PHH Mortgage Services, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20030314000154360, said mortgage having subsequently been transferred and assigned to LakeView Loan Servicing, LLC , by instrument recorded in Instrument Number 20170213000052980, in the aforesaid Probate Office ("Transferee"); and

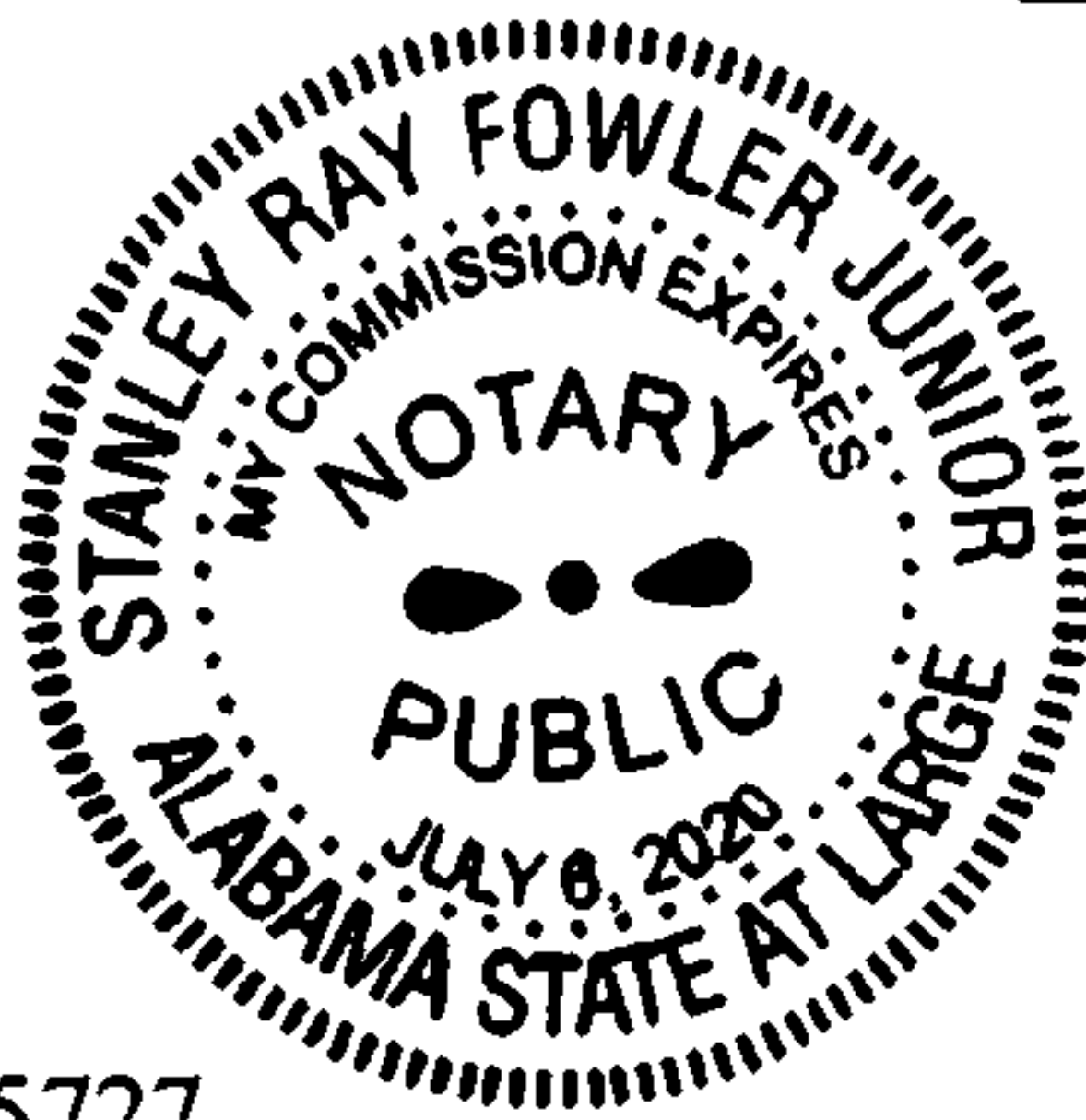
