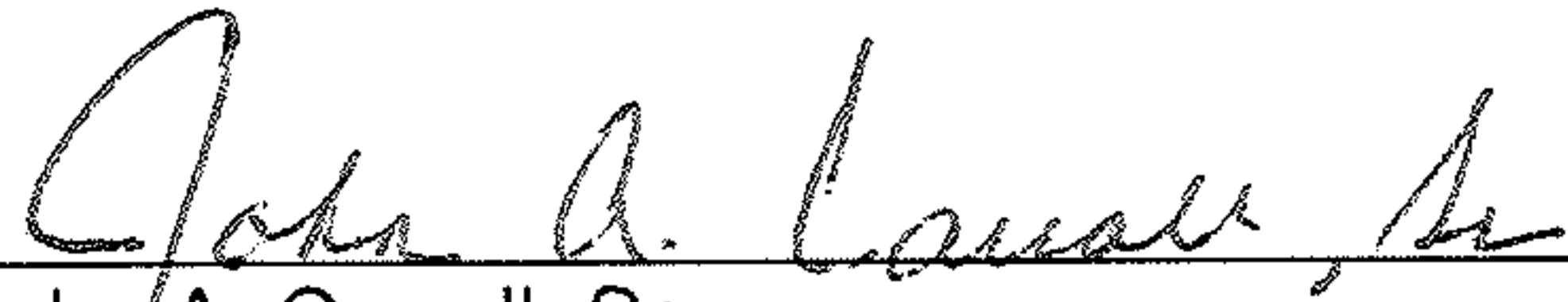

- Subject to:

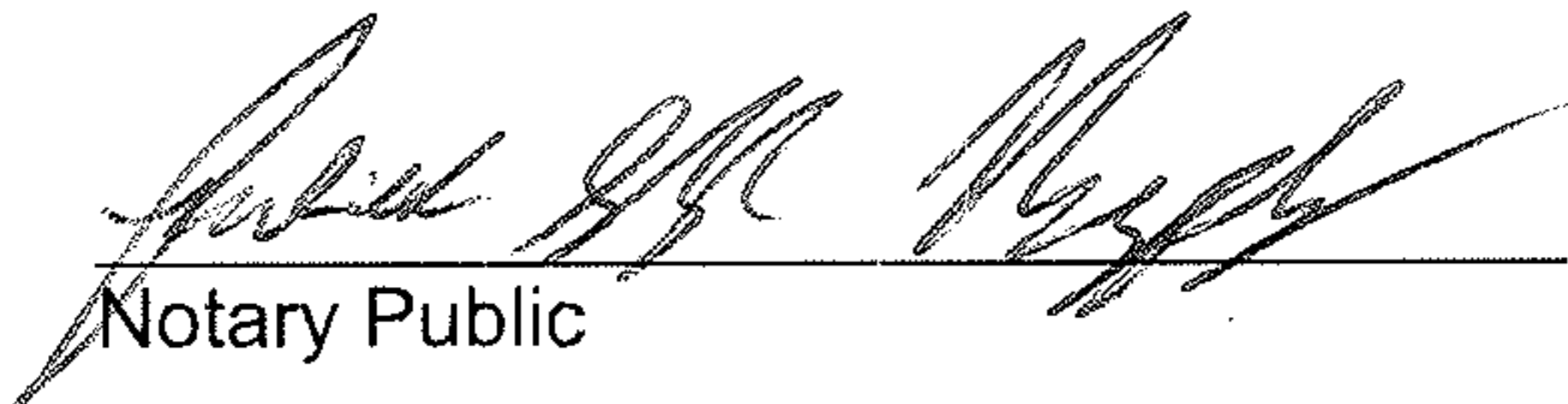

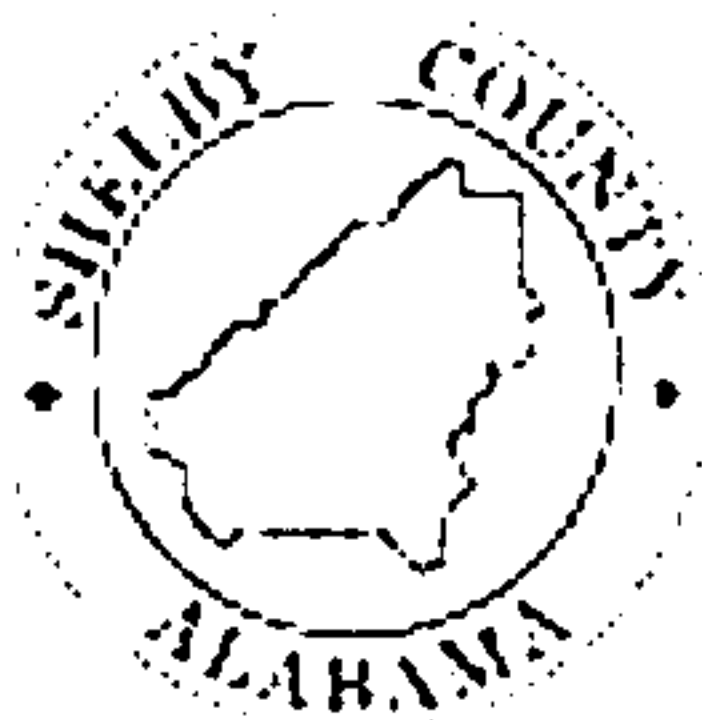
