The Trustees under the Trust Agreement are authorized [t]o borrow money for any purposes of the trust, or incidental to the administration thereof, upon the bond or promissory note of the Trustee noting in such capacity, and to secure the repayment thereof by mortgaging, creating a security interest in, or pledging or otherwise encumbering any part or all of the property of the trust, and, with respect to the purchase of any property, as part of the consideration given,

therefor, to assume a liability of the transferee or to acquire such property subject to a liability. (ITEM X Sec. 16).

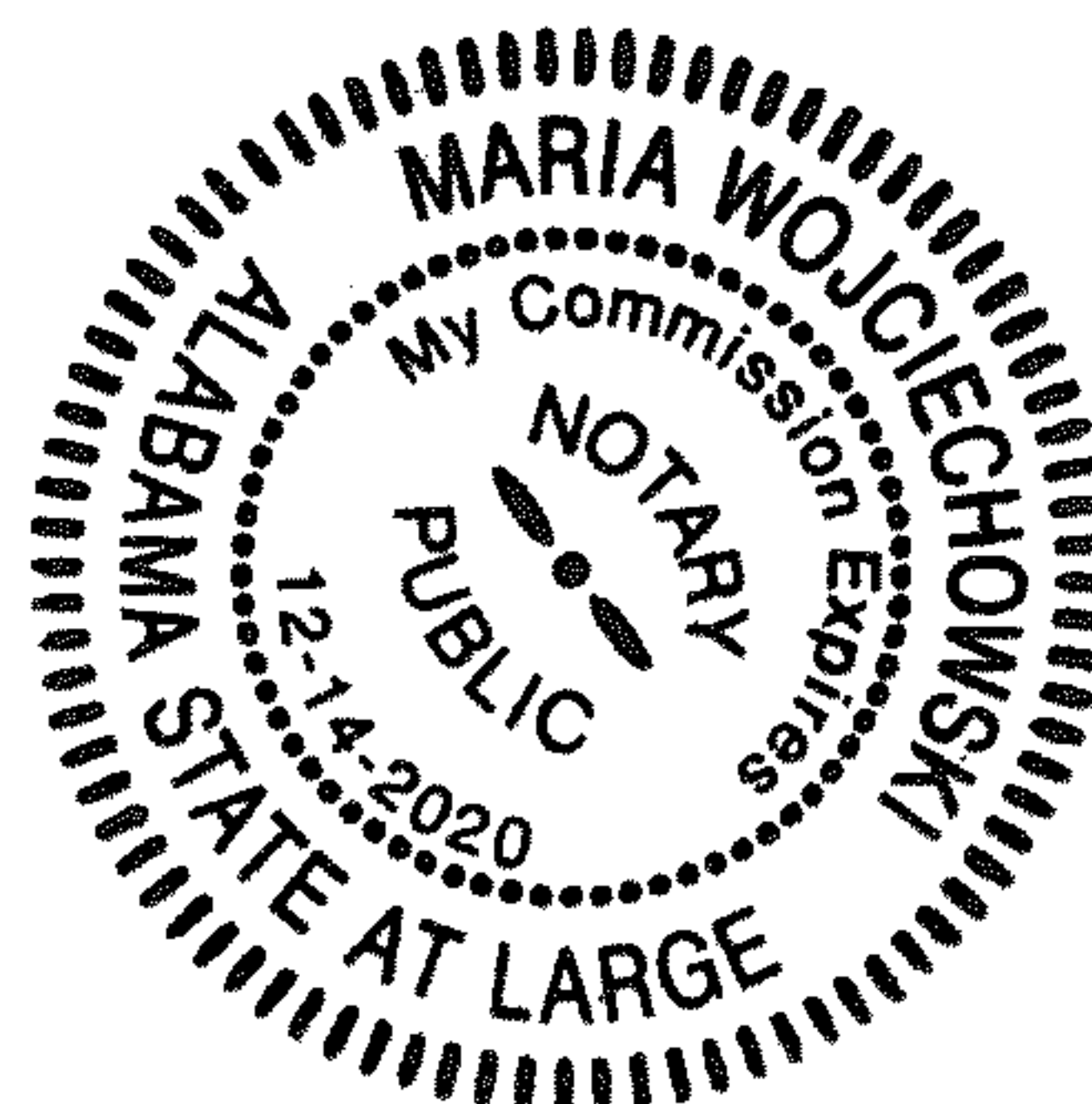
