By typographical error, the Warranty Deed prepared specified the Grantor as James B. Gober and wife, Pat Gober, instead of James R. Gober and wife, Pat Gober.


Said Warranty Deed was to show the Grantee as James R. Gober and Patricia E. Gober, Trustees, or their successors in trust, under the Gober Revocable Trust, dated June 20, 2012, and any amendments thereto.

By typographical error, the Warranty Deed prepared specified the Grantee as James B. Gober and Patricia E. Gober, Trustees, or their successors in trust, under the Gober Revocable Trust, dated June 20, 2012, and any amendments thereto, instead of James R. Gober and Patricia E. Gober, Trustees, or their successors in trust, under the Gober Revocable Trust, dated June 20, 2012, and any amendments thereto.

The error was mine and the intent was to show the Grantor's name and the Grantee's Trustee name and the Grantor's name as James R. Gober, not James B. Gober.



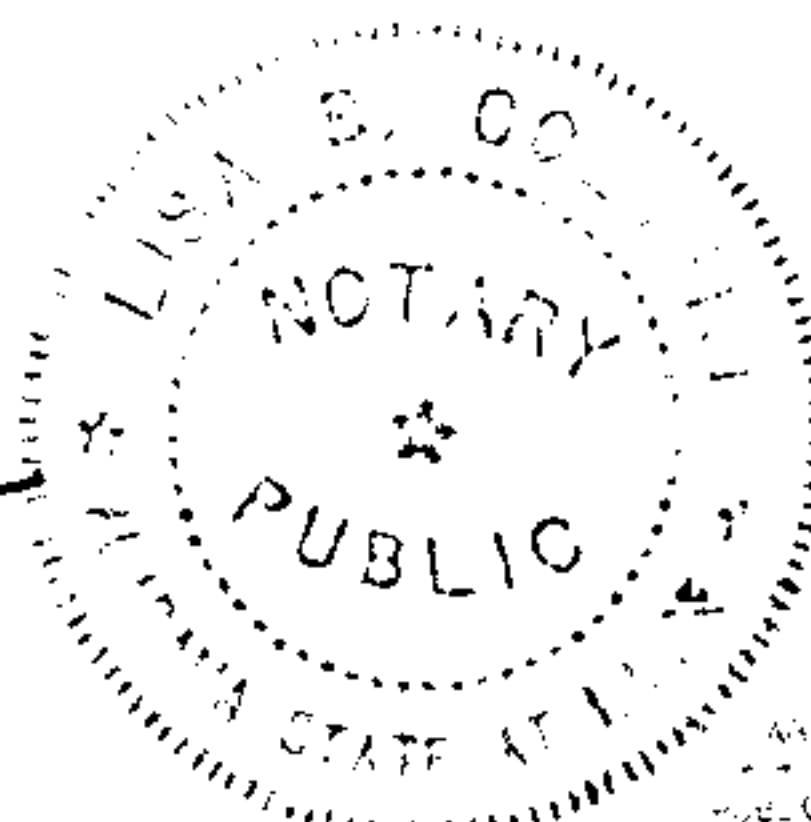
