That in consideration of the sum of **One Hundred Fifteen Thousand Four Hundred Forty Dollars and No Cents (\$115,440.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Nicole Andrews and Evan Andrews, Wife and Husband** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Cara Overton and Seth Overton**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, **the address of which is 30 Oakland Avenue, Wilsonville, AL 35186-8100**; to wit;

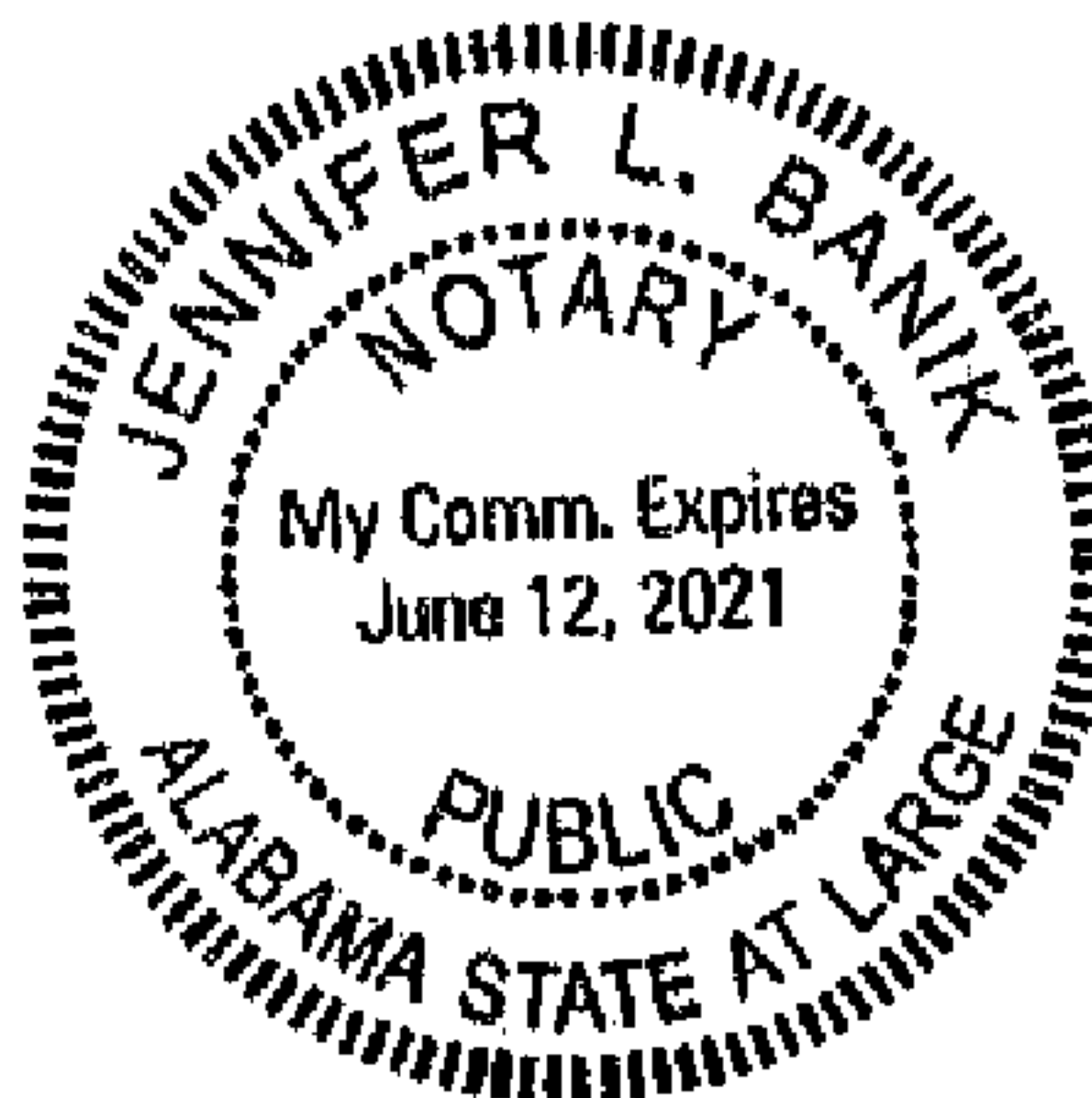
