FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 5th day of September, 2002, Terry Provines, unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for MortgageSouth, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20020913000439500, said mortgage having subsequently been transferred and assigned to Green Tree Servicing LLC, by instrument recorded in Instrument No. 20140407000098460, in the aforesaid Probate Office ("Transferee"); and

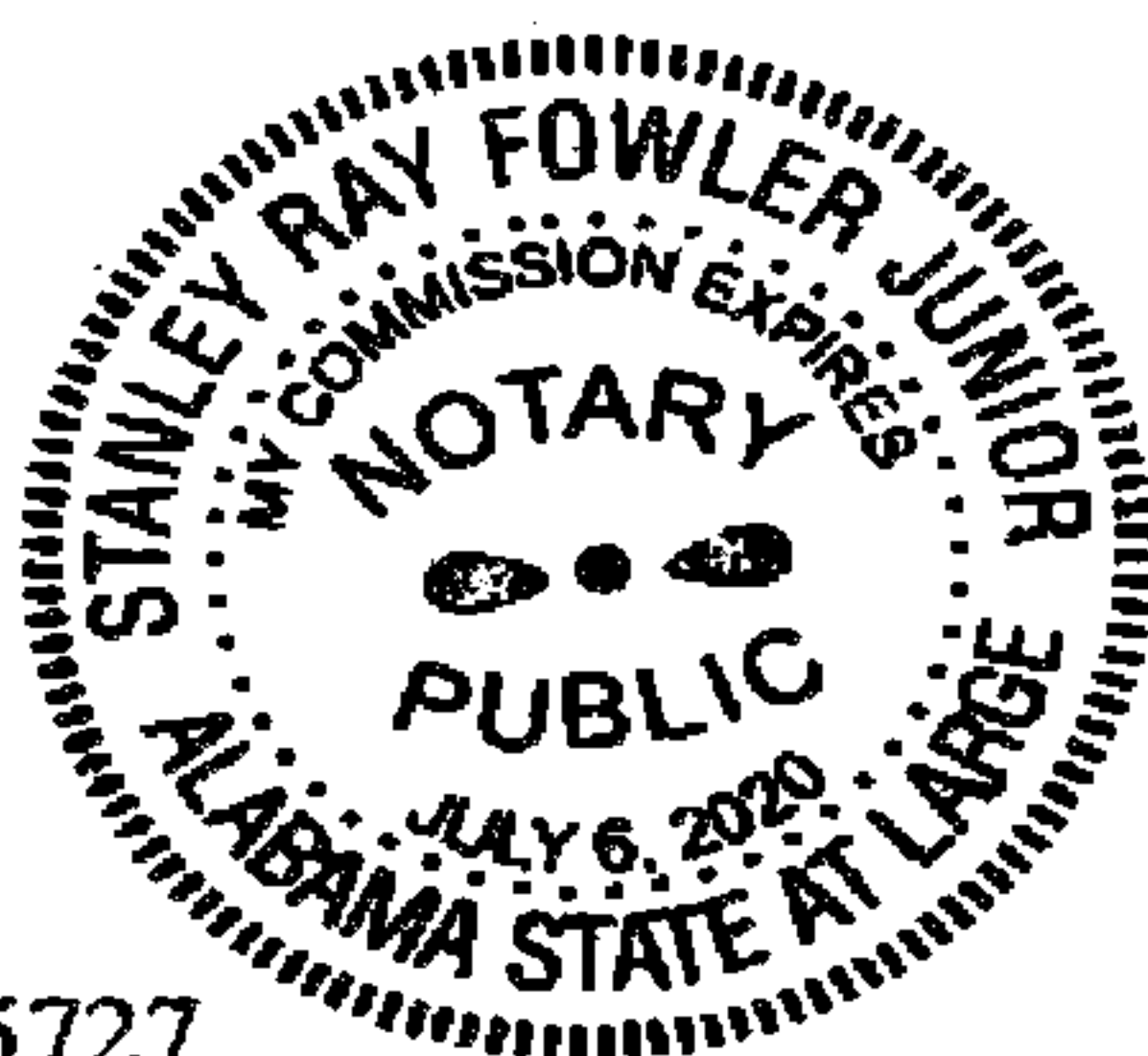
