ARTICLES OF ORGANIZATION

OF

Ally Construction LLC

AN ALABAMA LIMITED LIABILITY COMPANY

The undersigned, in order to form a limited liability company under and pursuant to the laws of the State of Alabama, hereby adopt the following Articles of Organization:

1. NAME: Ally Construction LLC

2. PERIOD OF DURATION: The period for the duration of the company shall be perpetual, unless otherwise dissolved pursuant to its Operating Agreement, which shall be maintained in the company's registered office.

3. PURPOSE: The purpose for building new construction and remodeling of old construction in a business manner legally exercised by limited liability companies under the Alabama Limited Liability Company Act including but not limited to:

(a) In furtherance but not in limitation of the aforesaid purposes of this company and without limitation of the powers conferred by statute or general rules of law, this company shall have the following powers in addition to other now or hereafter conferred by law:

(i) To enter into, make and perform contracts involving building new construction and remodeling of old construction of every kind, for any lawful purpose, without limit as to amount or duration, with any person, firm, partnership, trust, estate, association, corporation, limited liability company, state, territory, municipality, county, government, governmental district, body politic, or any subdivision or instrumentality thereof.

(ii) To participate with any person, partnership, trust, estate, firm, association, corporation or limited liability company in any general partnership, limited partnership (whether as general partner or as limited partner, or both), joint venture, syndicate, pool or other association involving building new construction or remodeling of old construction through any lawful arrangements for sharing of profits, union of interest, syndication, pooling of

interest, reciprocal concession, joint ownership, or cooperation, as partner (general or limited), joint venturer, or otherwise, with any person, partnership, trust, estate, firm, association, corporation or limited liability company.

(iii) Subject to the limitations and restrictions imposed by Alabama law or by the law of any other jurisdiction whose law is applicable in the premises, to indemnify any person who was or is threatened to be made a party to any threatened, pending, or completed claim, action, suit or proceeding, whether civil, criminal, administrative or investigative, including appeals and including actions by or in the right of the company, by reason of the fact that he or she is or was a member, employee or agent of this company, or is or was serving at the request of this company as a member, partner, employee or agent of another limited liability company, corporation, partnership, joint venture, trust or other enterprise, against expenses (including attorneys' fees) and (if such action is not by or in the right of the company) judgments, fines and amounts paid in settlement actually and reasonably incurred by him or her in connection with the defense or settlement of such claim, action, suit or proceeding if he or she acted in good faith and in a manner he or she reasonably believed to be in or not opposed to the best interests of the company; and to purchase and maintain insurance on behalf of any such person who is or was a member, employee or agent of this company or is or was serving at the request of the company as a member, partner, employee or agent of another limited liability company, corporation, partnership, joint venture, trust or other enterprise against any liability asserted against him or her and incurred by him or her in any such capacity or arising out of his or her status as such, whether or not this company would have the power to indemnify him or her against such liability.


(iv) To transact any lawful business which the members find to be in aid of governmental policy involved in the building of new construction and remodeling of old construction.

(c) To have and exercise all powers necessary or convenient to affect its purposes, including its purpose to carry on any or all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act.
