On this December 7, 2018, That for and in consideration of **ONE HUNDRED TWENTY EIGHT THOUSAND AND NO/100 (\$128,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **RICHARD R. VINCIGUERRA, a married person**, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **JUSTIN THURBER**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot A, Block 19, according to the Amended Map of Riverwood, Fourth Sector, as recorded in Map Book 8, Page 136, in the Probate Office of Shelby County, Alabama, together with an undivided interest in the common area as set forth in Declarations recorded in Misc. 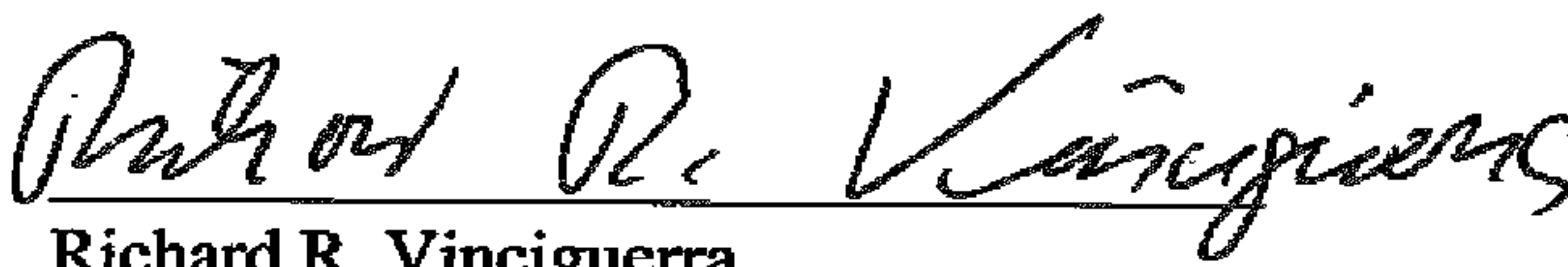
The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

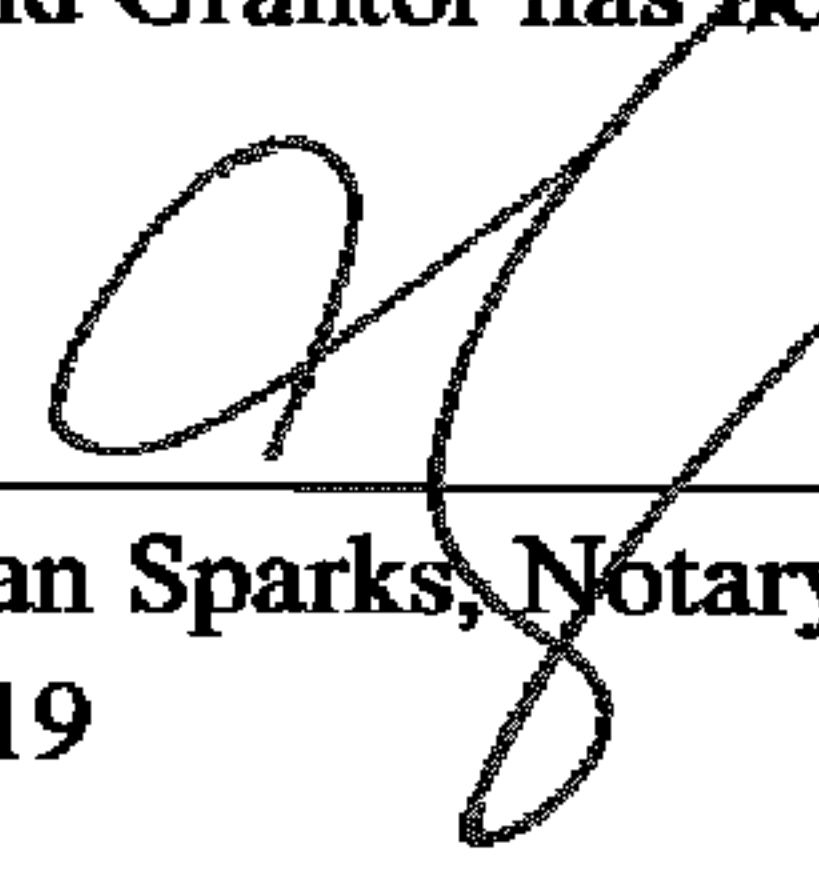
