KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Three Hundred Thousand And No/100 Dollars (\$300,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Russell G. Powers and Melissa D. Powers, a married couple (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Lee Hargreave and Alexa Hargreave (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 47A, according to the Amended Hillsboro Subdivision Phase I, as recorded in Map Book 39, Page 140 A, B and C, in the Probate Office of Shelby County, Alabama.
