KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of March, 2009, Charles B. Clements, Jr. and Sally G. Clements, husband and wife, executed that certain mortgage on real property hereinafter described to Urban Financial Group, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20090310000087320, said mortgage having subsequently been transferred and assigned to Reverse Mortgage Solutions, Inc., by instrument recorded in Instrument Number 20131212000477840, in the aforesaid Probate Office ("Transferee"); and

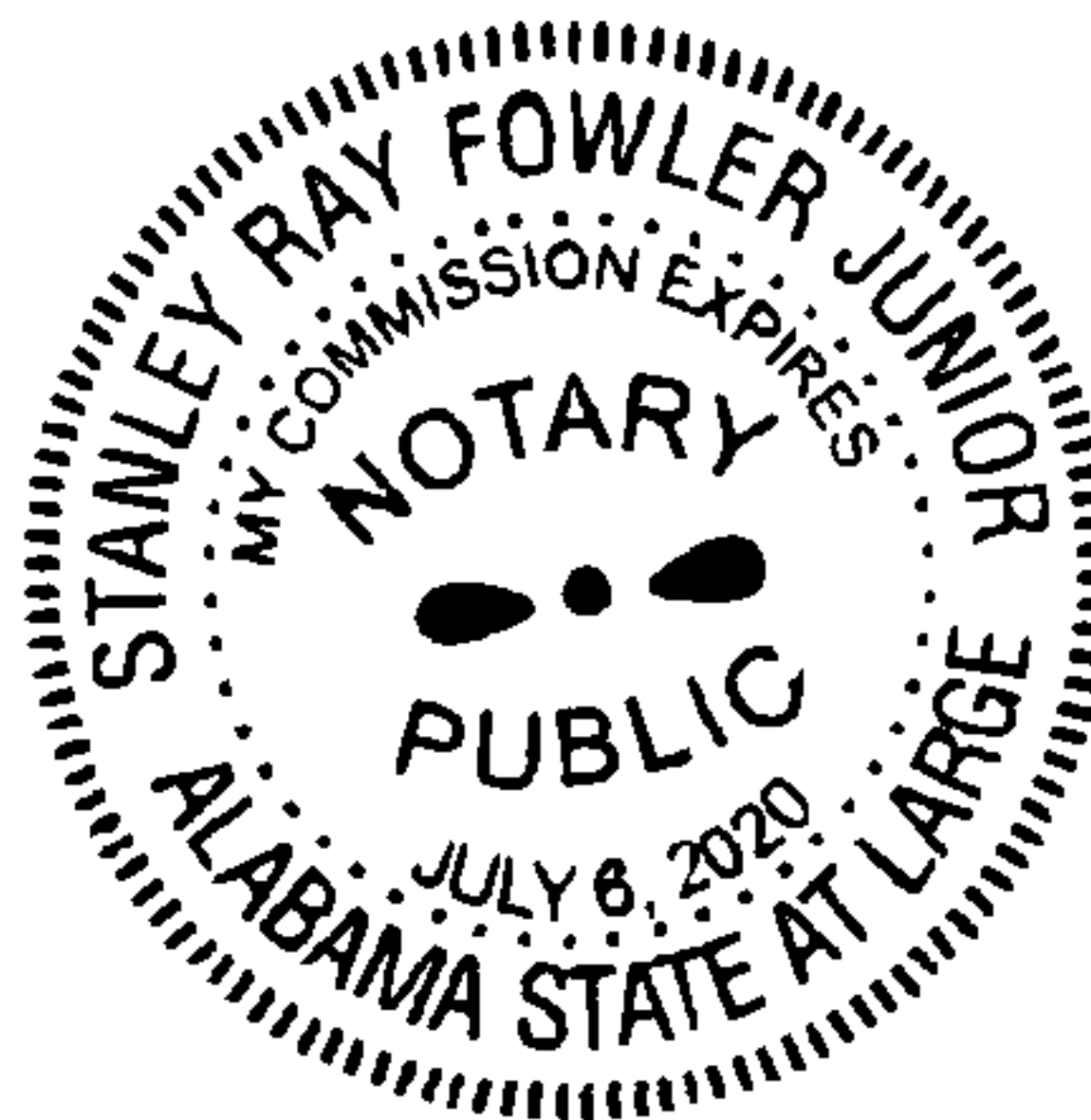

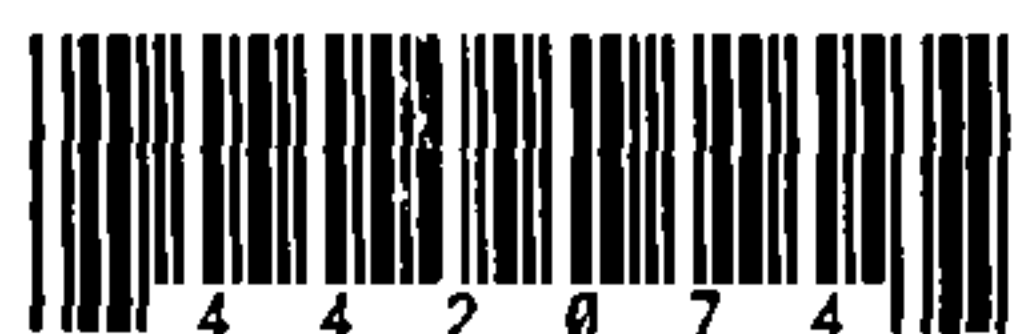

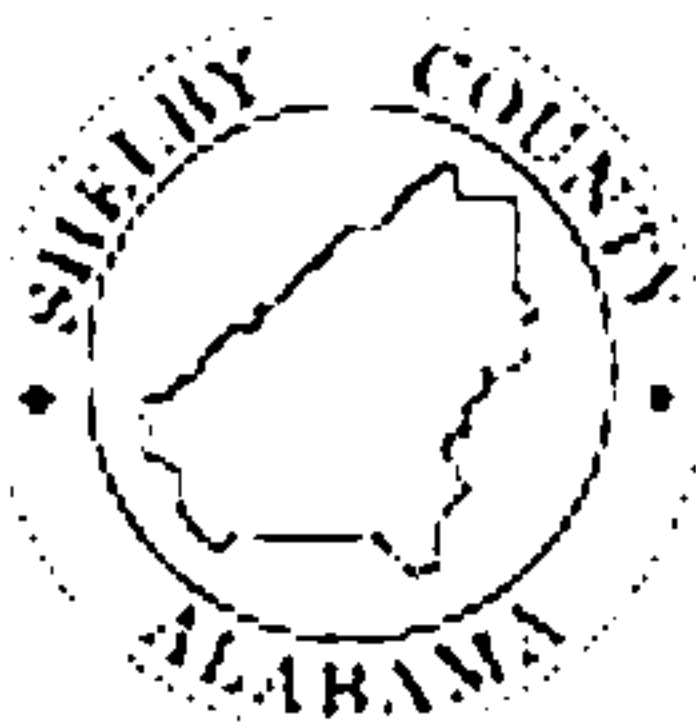
