KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of July, 2010, Theodore M. Pritchett and Jo Ann H. Pritchett, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for United Wholesale Mortgage, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20100825000274120, said mortgage having subsequently been transferred and assigned to NationStar Mortgage LLC d/b/a Mr. Cooper, by instrument recorded in Instrument number 20181011000362150, in the aforesaid Probate Office ("Transferee"); and

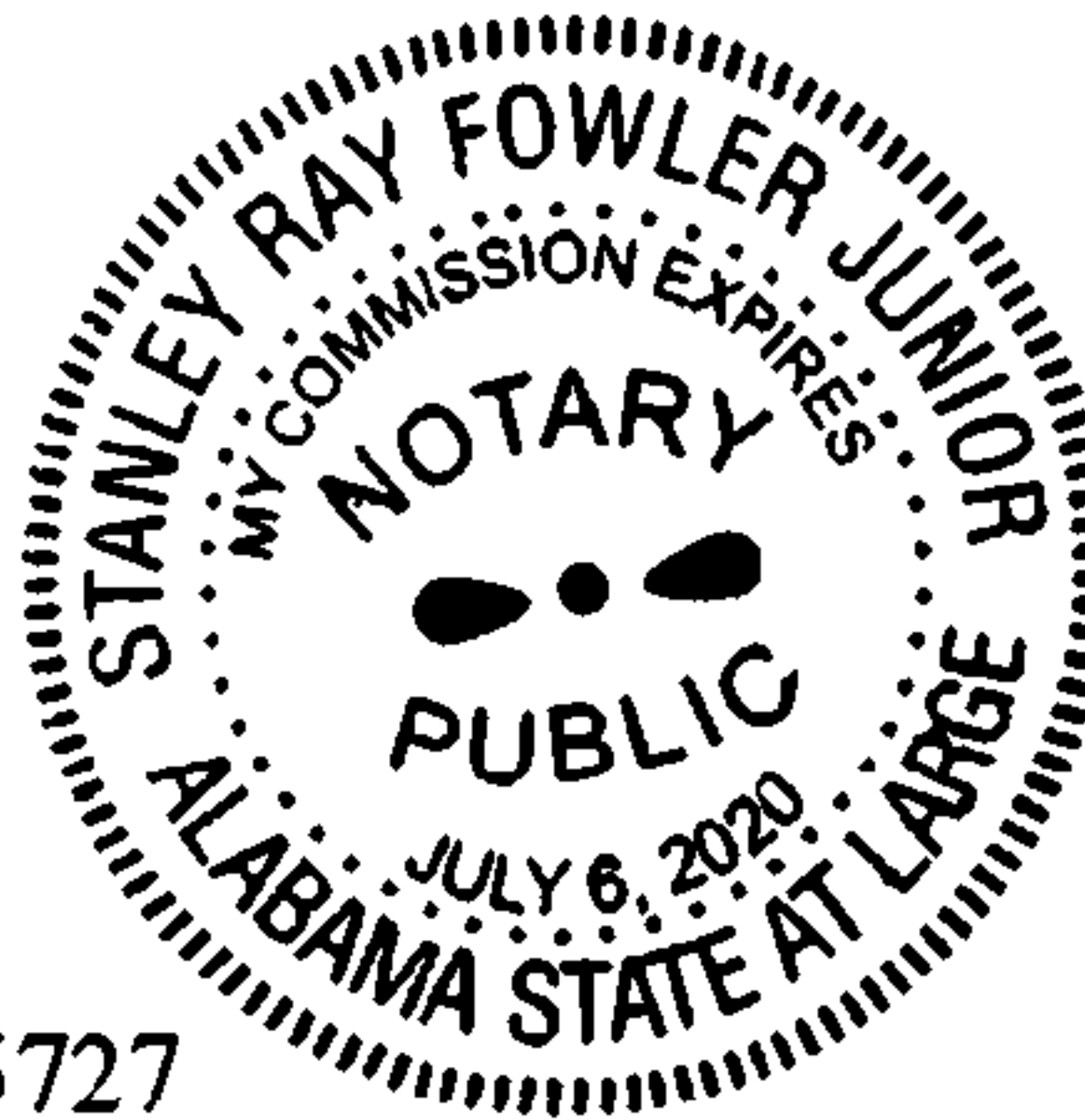
