I will not question the sufficiency of any instrument executed by my said Attorney-in-Fact pursuant to this power notwithstanding that the instrument fails to recite the consideration therefore, or recites merely a nominal consideration; any person dealing with the subject matter of such instrument may do so as if full consideration therefor had been expressed therein.

This Power of Attorney shall be a Specific Power of Attorney and shall not be affected by the disability, incompetency or incapacity of the Principal.


