KNOW ALL MEN BY THESE PRESENTS, That in consideration **ONE HUNDRED SEVENTEEN THOUSAND SIX HUNDRED AND NO/00 DOLLARS (\$117,600.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, ***Susan Barringer, a married woman*** (herein referred to as ***Grantor***) grant, bargain, sell and convey unto ***Alfred A. Lamoureux, Jr and Jennifer O. Lamoureux*** (herein referred to as ***Grantees***), the following described real estate, situated in: **SHELBY County, Alabama**, to-wit:

Lot 5, according to the Map and Survey of Donna Robinson Subdivision, as recorded in Map Book 34, page 150, in the Probate Office of Shelby County, Alabama.

SUBJECT TO:

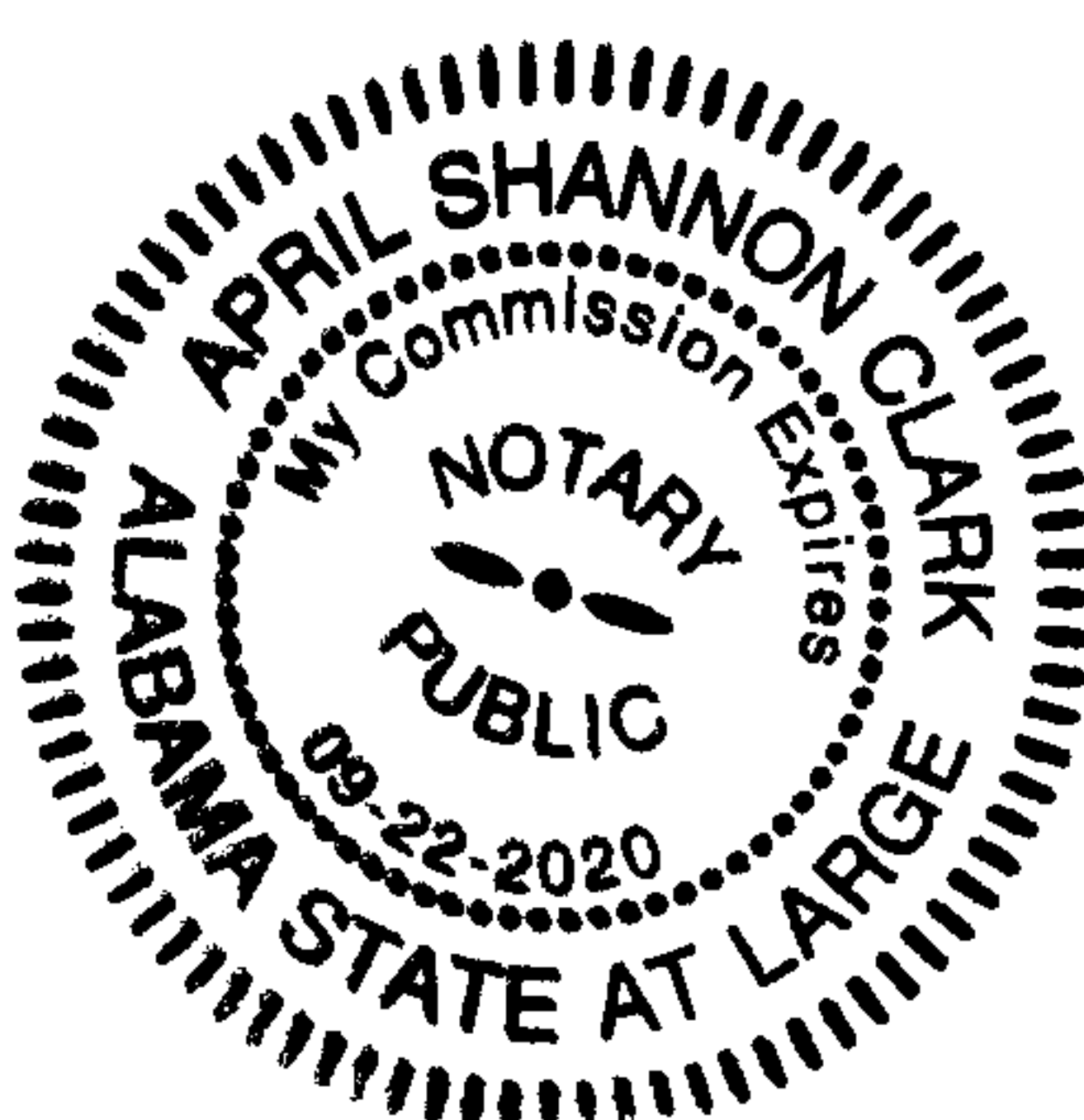



