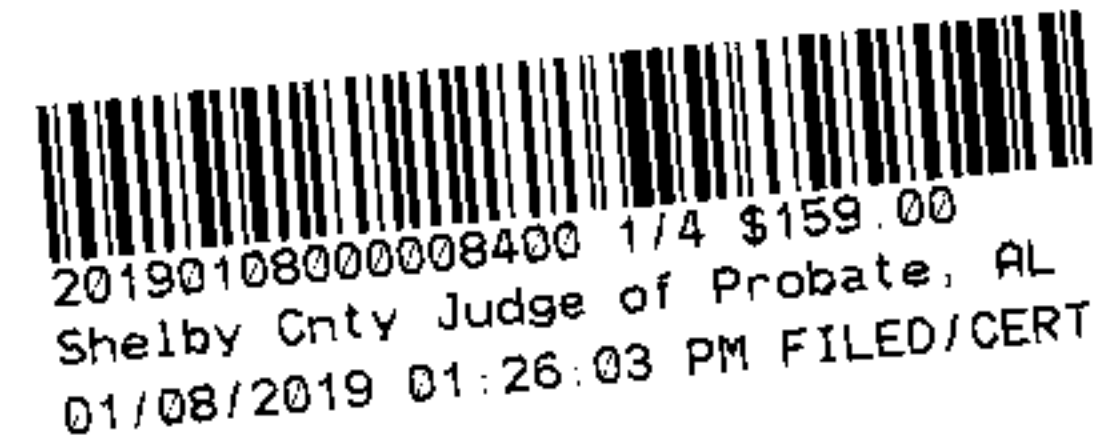

**ARTICLES OF ORGANIZATION  
OF  
MKBroadcast II, LLC**



**TO HONORABLE JUDGE OF PROBATE  
OF SHELBY COUNTY, ALABAMA:**

The undersigned, for the purpose of forming a limited liability company under Title 10A of the Code of Alabama (1975), as amended (the “Alabama Business and Nonprofit Entities Code”), hereby files the following Articles of Organization with the Probate Judge of the County in which the initial registered office of the limited liability company will be located and attests that the facts stated in these Articles of Organization are true and correct:

**ARTICLE I  
NAME**

The name of this limited liability company (the “Company”) shall be:

MKBroadcast II, LLC

**ARTICLE II  
TYPE**

The Company is a limited liability company.

**ARTICLE III  
PURPOSES**

The nature of the business of the Company and its objects, purposes and powers are as follows:

- (a) To purchase, hold, sell and invest in media companies, real estate, or other business ventures;
- (b) To manage, purchase or acquire by assignment, transfer or otherwise, and hold, mortgage or otherwise pledge, and to sell, exchange, transfer, deal in and in any manner dispose of, real or personal property of any kind, class, interest or type, wheresoever situated, and to exercise, carry

out and enjoy any license, power, authority, concession, right or privilege which any limited liability may make or grant in connection therewith; and

(c) In general, to carry on any other lawful business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the Company is empowered to exercise, whether expressly by purpose or by any of the laws of the State of Alabama or any reasonable construction of such laws.

#### **ARTICLE IV DURATION**

The period of duration is perpetual unless the Company shall be sooner dissolved and its affairs wound up in accordance with its Articles of Organization or Operating Agreement.

#### **ARTICLE V REGISTERED AGENT/OFFICE**

The location and mailing address of the initial registered office of the Company shall be 169 Chelsea Station Drive, Chelsea, Alabama 35043 and its registered agent at such address shall be **Joshua A. Bohn**.

#### **ARTICLE VI ADDITIONAL MEMBERS**

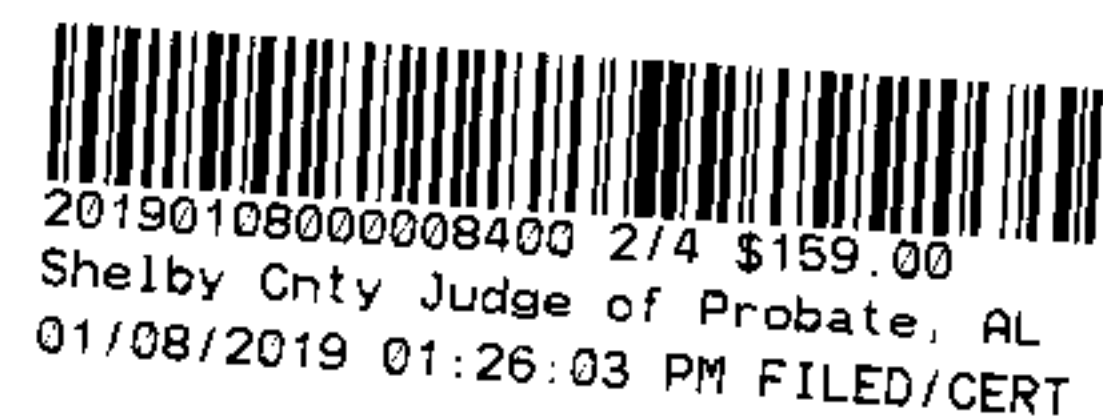
The initial member (the "Member") of the Company reserves the right to admit additional members upon the consideration to be paid by, such new members, and subject to the terms and conditions of the Company's Operating Agreement.

#### **ARTICLE VII OPERATING AGREEMENT**

The Operating Agreement of the Company shall be executed by the Members and shall set forth all provisions for the affairs of the Company and the conduct of its business to the extent that such provisions are not inconsistent with the laws of Alabama or these Articles of Organization.

#### **ARTICLE VIII CONTINUATION UPON CESSATION OF MEMBERS**

The Members shall have the right to continue the Company upon the cessation of a Member's interest in the Company as long as there is at least one remaining Member or (i) the holders of all of the financial rights in the Company agree in writing within ninety (90) days of the cessation of membership of the last Member to continue the legal existence and business of the Company and to appoint one or more Members or (ii) the legal existence and business of the Company is continued and one or more members are appointed in the manner stated in the Operating Agreement or the Articles of Organization.



**ARTICLE IX  
MANAGEMENT**

The Company shall be managed by a Manager. The name and address of the initial Manager of the Company are as follows:



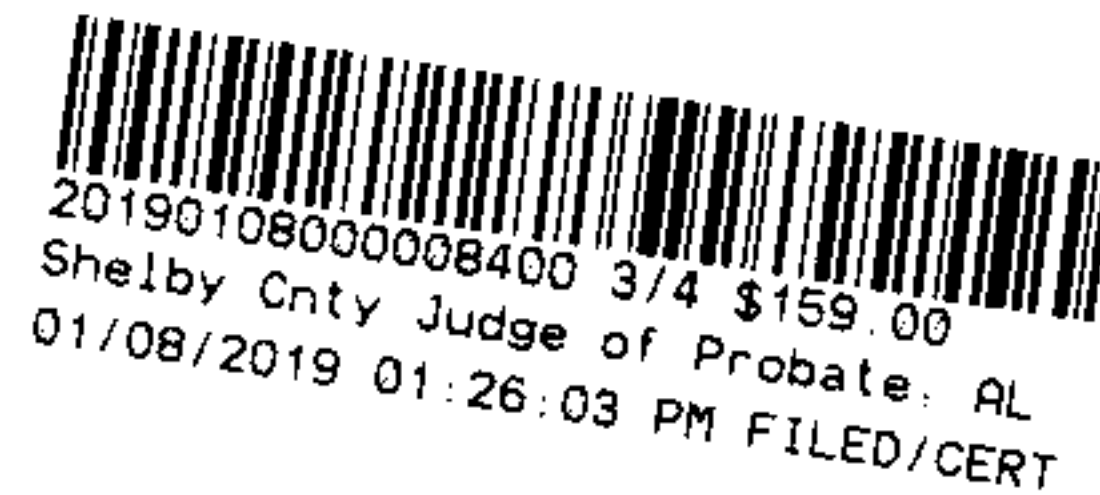
