The objects and purposes for which the said Limited Liability Company is formed and the objects to be carried on and promoted by it are as follows

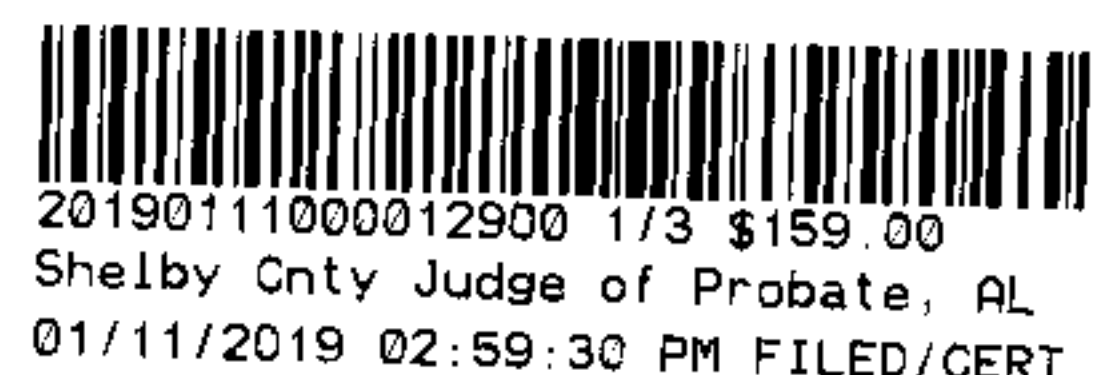
