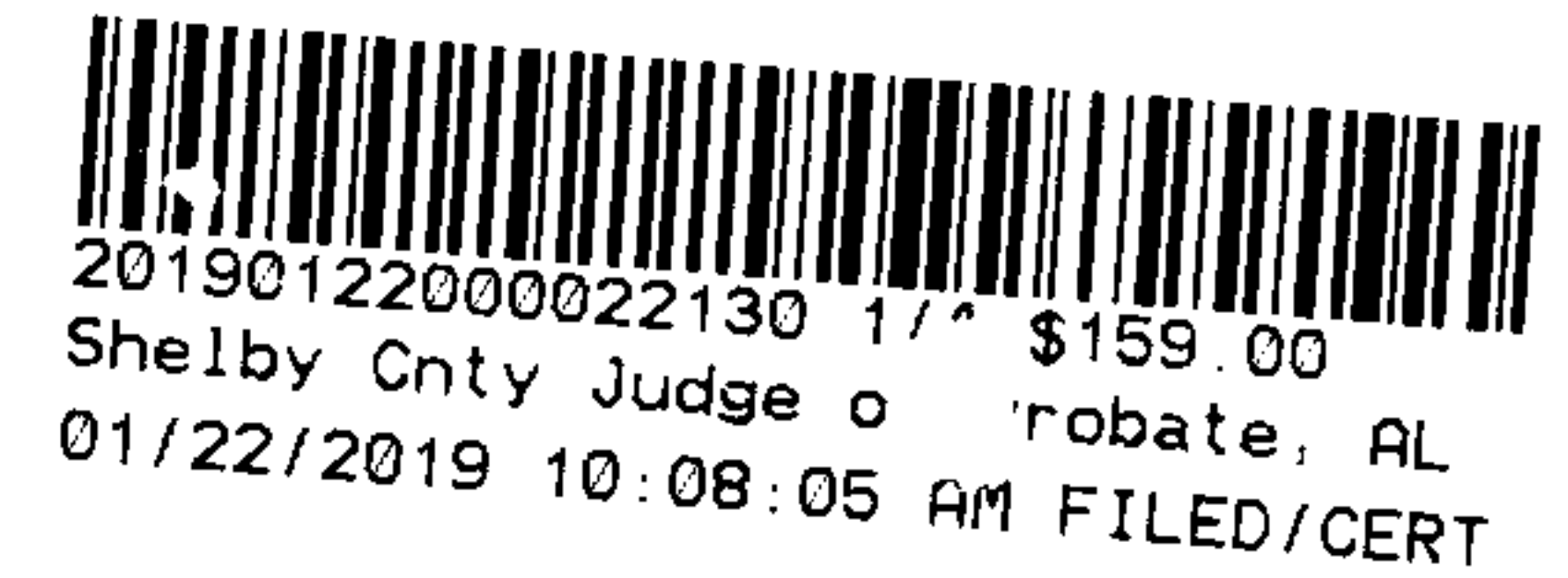


CERTIFICATE OF FORMATION
OF
EASY-CHEESY-FREEZY, LLC



The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Code of Alabama, (1975) as amended known as the “Alabama Limited Liability Company Act”, hereby files the following Certificate of Formation with the Probate Judge of the county in which the initial registered office of the limited liability company will be located and affirm the facts stated in this Certificate of Formation are true and correct:

ARTICLE I

Name

The name of the limited liability company (“Company”) is EASY-CHEESY-FREEZY, LLC.

ARTICLE II

Duration

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act, as amended.

ARTICLE III

Purposes

The Company has been organized for the primary purpose of providing a mobile concession stand serving sandwiches, shaved ice and other edible foods and beverages at various venues and events and for any lawful purpose or purposes for which a limited liability company may be organized under the laws of the State of Alabama.

ARTICLE IV

Registered Agent and Office

The address of the Company's initial registered office in Alabama is 268 Strathaven Lane, Pelham, Alabama 35124. The name of the Company's initial registered agent at that address is Kimberly A. Sims.

ARTICLE V

Organizer

ARTICLE VI

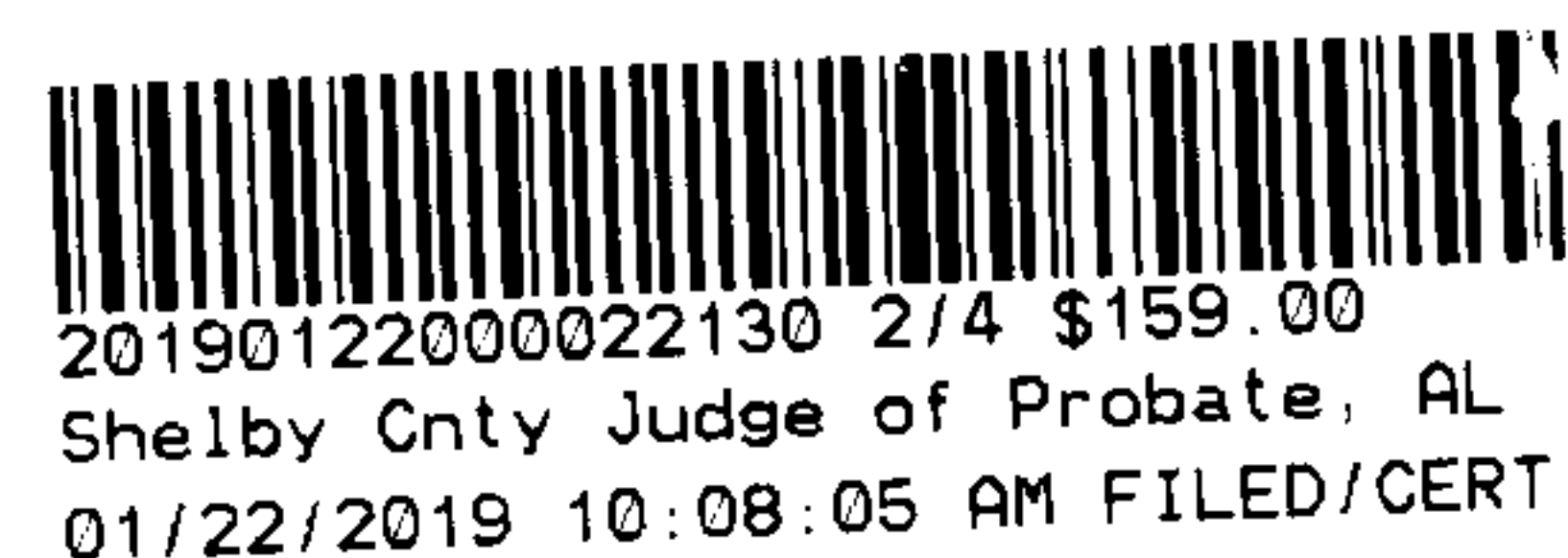
Management

The Company shall be managed by its initial member. In the event that additional members are admitted pursuant to Article VII, the Company shall be managed by its members with each member having an equal right to participate in such management.

ARTICLE VII

Admission of New Members

The sole member of the Company shall have the right to admit new members from time to time. In the event the sole member has admitted new members, any additional members may be admitted only upon the unanimous written consent of the existing members, and such existing members shall determine the amount and nature of contributions by new members at the time such new members are admitted.



ARTICLE VIII

Continuity of Business

Upon the death, retirement, resignation, expulsion, bankruptcy, dissolution, or disassociation of a member, or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall not be continued and the Company shall be dissolved unless there is obtained the written consent of all the remaining members of the Company within ninety (90) day after the occurrence of the terminating event.

ARTICLE IX

Powers


The Company shall have the same powers as a natural person to do all things necessary or convenient to carry out its business and affairs, including, without limitation, the powers set forth in Title 10-12-4, Code of Alabama (1975), as the same may hereafter be amended from time to time.

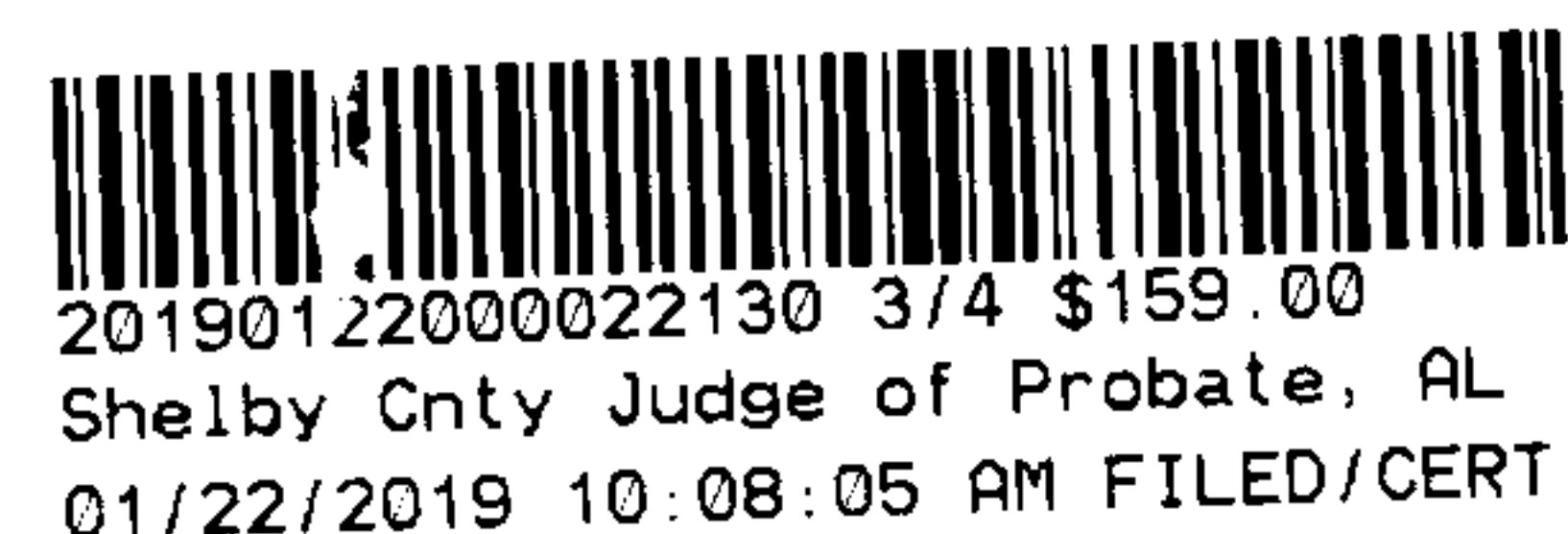
ARTICLE X

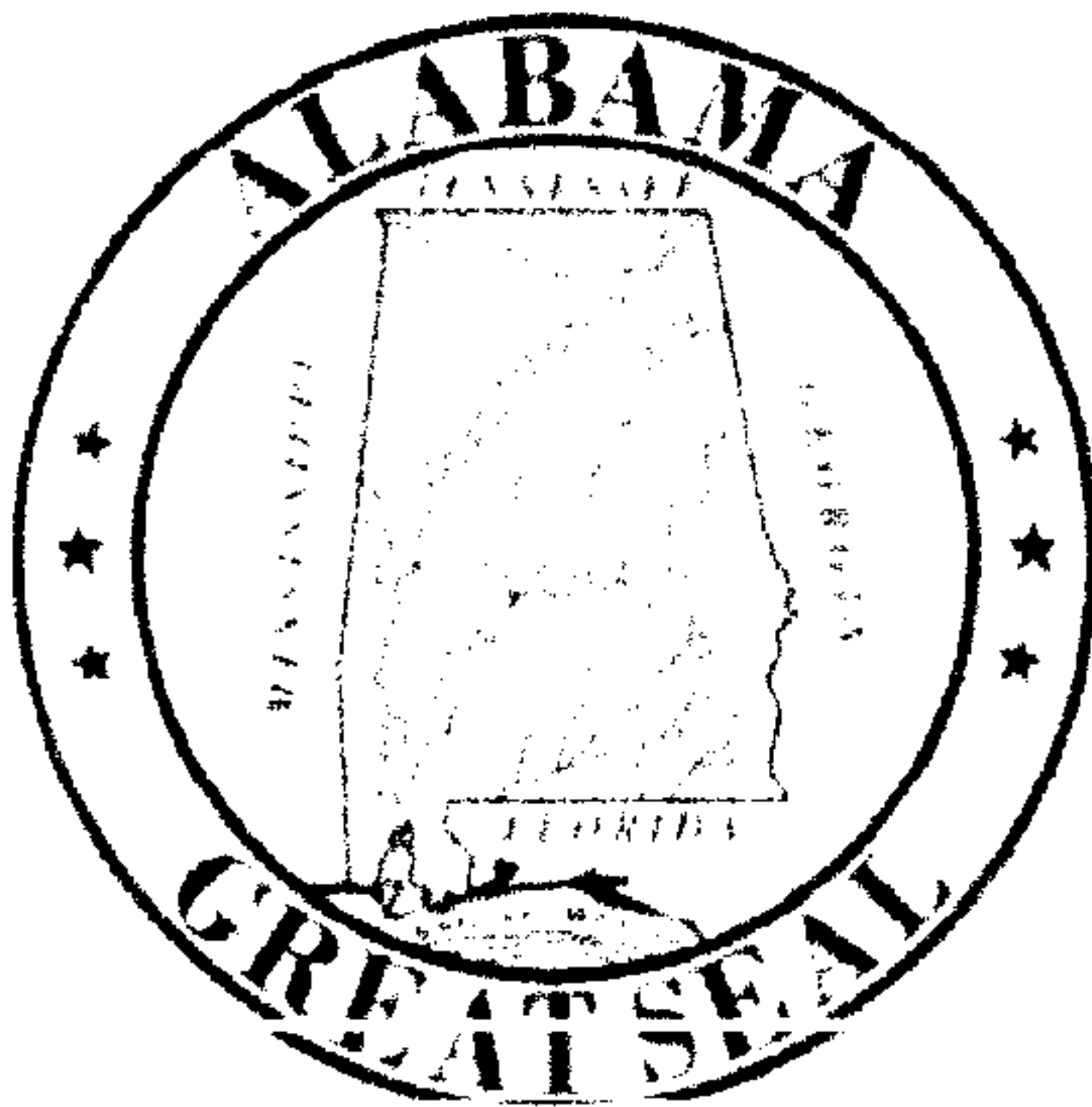
