
DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:



That I, HILDEGARD L. WEST, a resident citizen of the State of Alabama, Jefferson County, do hereby nominate, constitute and appoint DAVID M. WHLLIMAS, JR. my true, sufficient, and lawful attorney, for me and in my place and stead.

- 1. To demand, sue for collect recover, and receive all goods, claims debts, monies interest or demands of any kind whatsoever now due or that may hereafter be due to me or belong to me;
- 2. To make, execute, endorse, accept or delivery any and all bills of exchange, checks, drafts, or notes, and to use the same and/or the proceeds thereof for whatever purposes that my said attorney may see fit for my benefit;
- 3. To pay all sums of money at any time that may now or hereafter be owing by me or by my said attorney for me;
- 4. To defend, settle, adjust or compromise all actions, suits, accounts, claims, or demands whatsoever that may now or hereafter be pending between me and any legal entity in such manner as they shall see fit;
- 5. To buy, receive, lease, accept, or otherwise acquire, sell, convey, mortgage, hypothecate, pledge, execute deeds, or otherwise encumber or dispose of, or to contract or agree for the acquisition, disposal or encumbrance of, any property whatsoever situated, be it real, personal, interest or right therein or pertaining thereto, upon such terms as my said attorney shall think proper, including but not limited to my home;
- 6. To act as my attorney or proxy in respect to any stocks, shares or other securities or investments, including but not limited to certificates of deposits which I may now or hereafter hold, including the purchase and sale of same;
- 7. To open, maintain or close any or all accounts in any financial institution, including signing any documents necessary for same;
- 8. To make any and all health care decisions on my behalf or for my benefit;
- 9. To engage and dismiss attorneys at law, accountants, clerks, workmen or others in respect to any of the matters herein mentioned and upon such terms as my said attorney shall think fit in connection with these premises;
 - 10. To access any safety deposit box which I may have.

Giving and granting unto my said attorney full authority to do and perform each and every act, deed, matter and thing whatsoever in or about my estate and affairs set

forth as fully and effectively to all intents and purposes as I might or could do in my own proper person if personally present, the above enumerated powers being in aid and exemplification of the full, complete and general power herein granted and not in limitation thereof; and hereby ratifying all that my said attorney may lawfully do or cause to be done by virtue of these presents; and I hereby declare that any act or thing lawfully done or caused to be done by my said attorney shall be binding upon myself, my heirs, legal and personal representatives and assigns, whether the same shall have been prior to or after my death or other revocation of this instrument, unless and until reliable notice shall have been given or received by any person acting in reliance hereon of such revocation. This power of attorney shall not be affected by my subsequent disability, in competency or incapacity.
