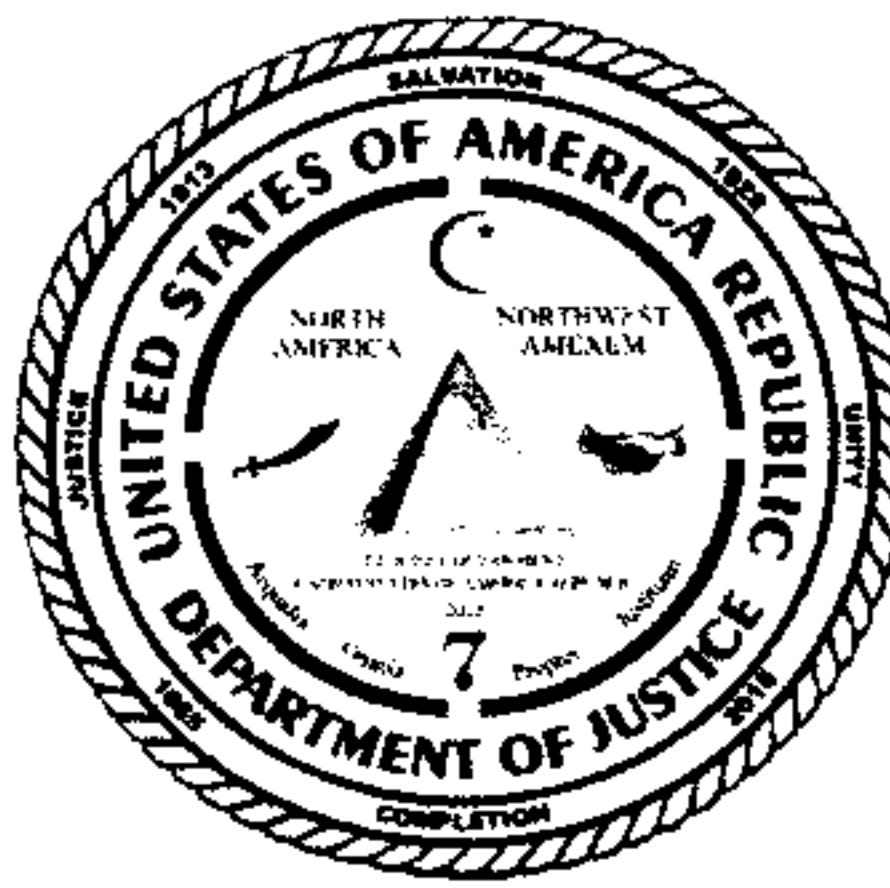
The term **"commercial crimes"** includes, but is not limited to any of the following federal or state **crimes**:

As fiduciary, heir, beneficiary, trustee and holder in due course let this also serve as **Legal Notice** that the Vessel involved is the property of the **United States of America Republic** and the Estate involved is an irrevocable fee simple absolute estate. **The statute of fraud and perjury as well as the parole evidence rule apply.**

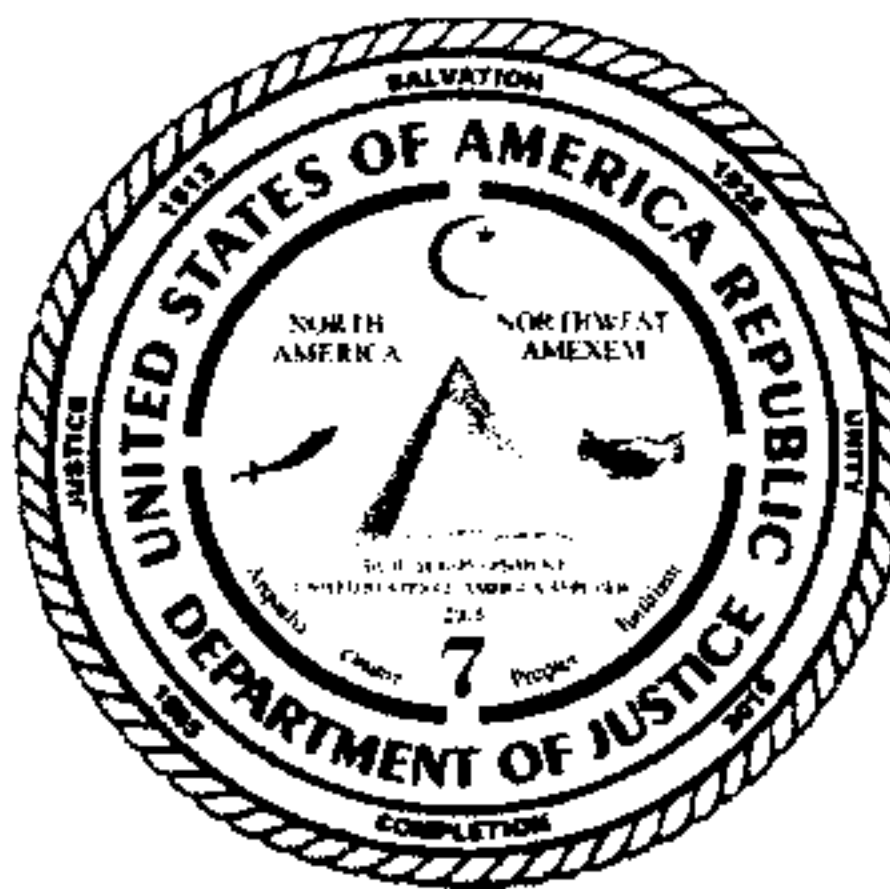
Intermediaries who hold unclaimed securities distributions in their own names are the relevant "debtors". Issuers cannot be considered "debtors" once they make distributions to intermediaries that are record owners and since payment to a record owner discharges all of an issuer's obligations to the beneficial owner under the **Uniform Commercial Code**, which is the law in all 50 States and the District of Columbia. Instead, an intermediary serving as the record owner is the "debtor" insofar as it has a contractual duty to transmit distributions to the beneficial owner. Unlike an issuer, it remains liable should a "lost" beneficial owner reappear to collect distributions due under such a contract.

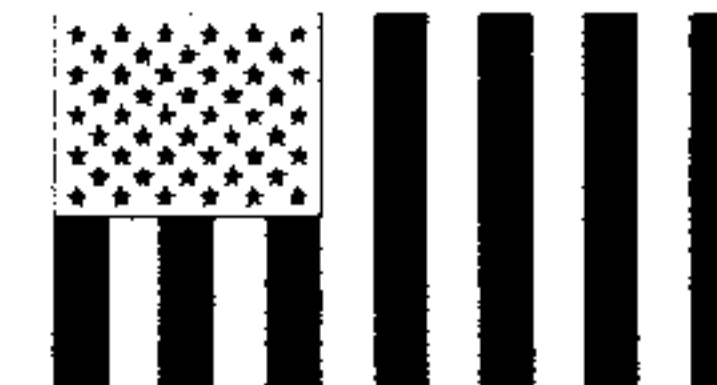

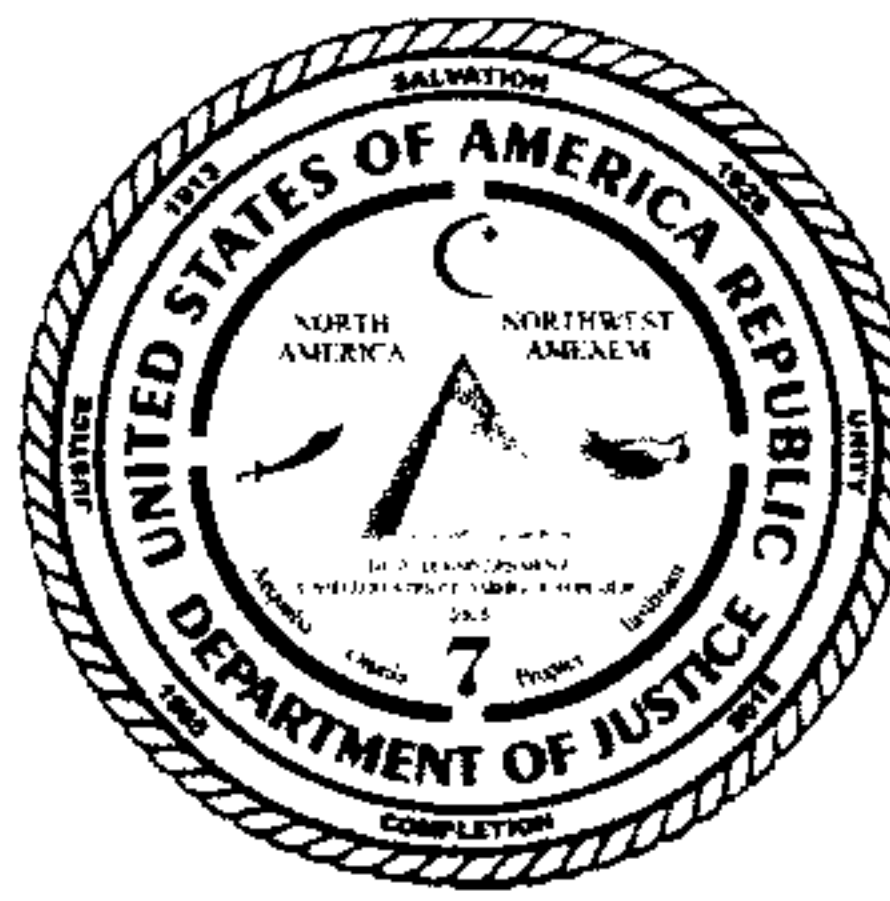

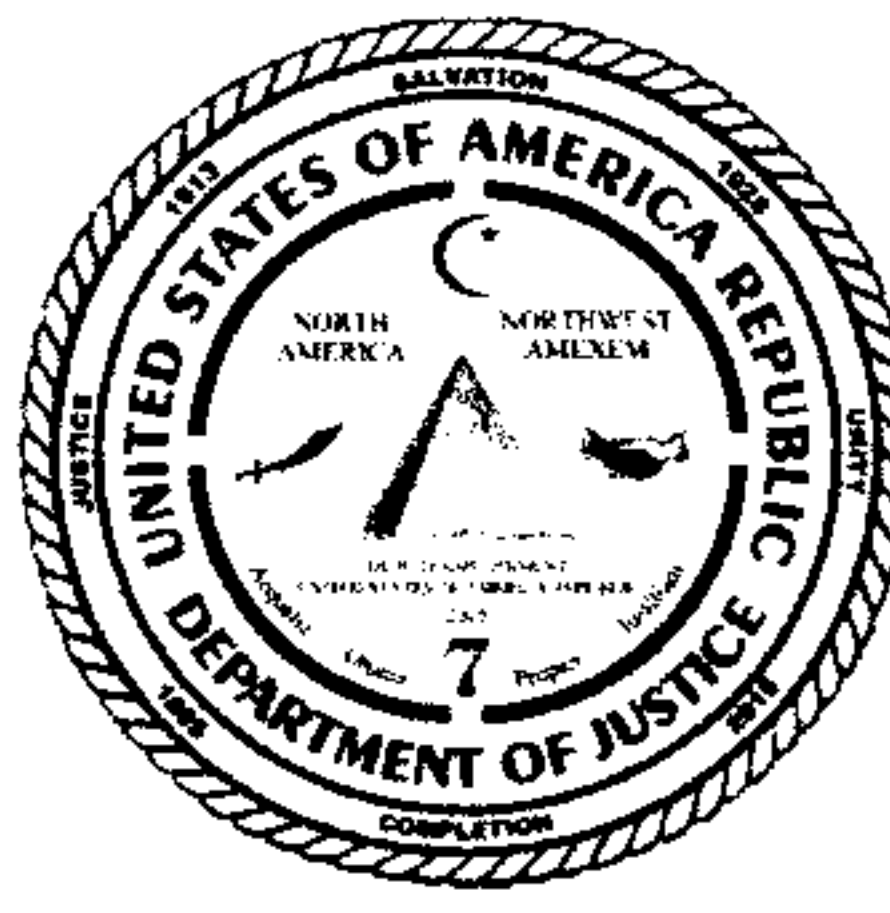
That any violation of the Constitutional Secured Rights of Moorish American people is a Trespass.

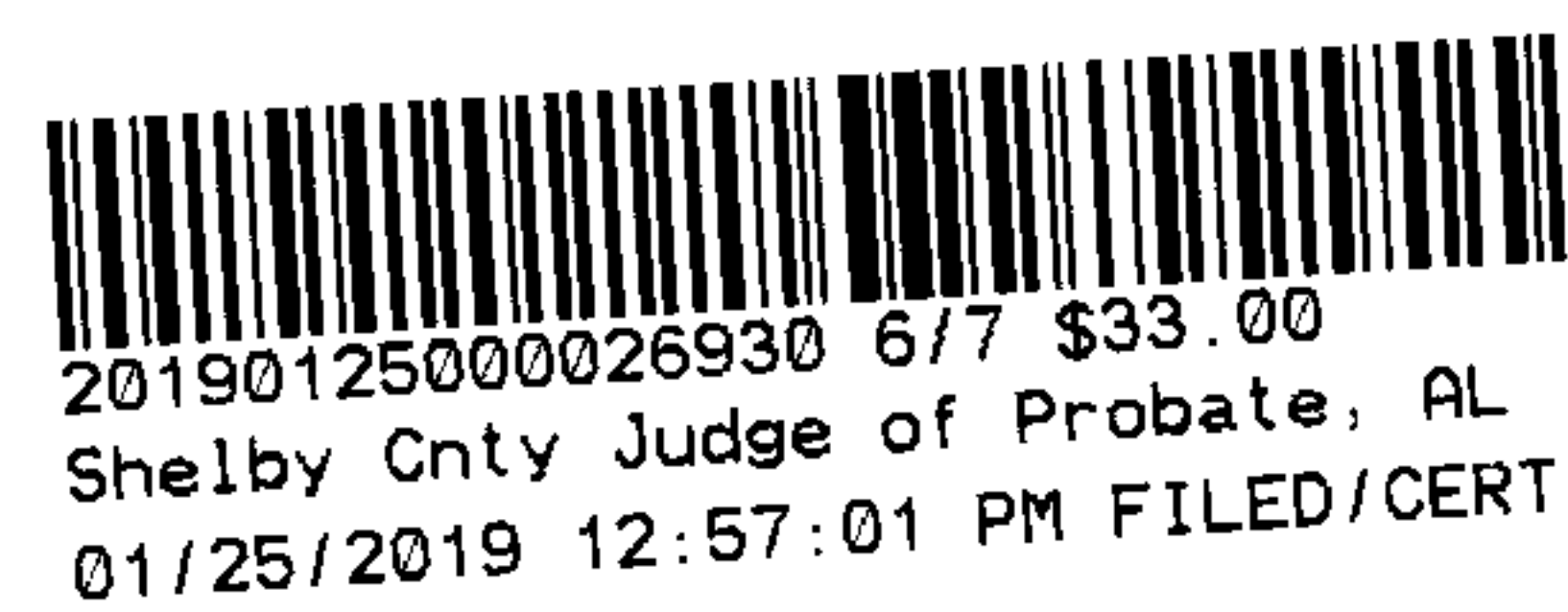
**(7) YOU AGREE:**
