Further, FNA makes no warranties or representations as to the condition of the title of THE PROPERTY, or to the ability of GLOBAL or its successors or assignees to obtain a tax deed to THE PROPERTY. In the event of redemption, GLOBAL shall not be entitled to any refund of payment made to FNA under this Agreement.
