WHEREAS, heretofore, on, to-wit: the 24th day of March, 2006, Rosa M. 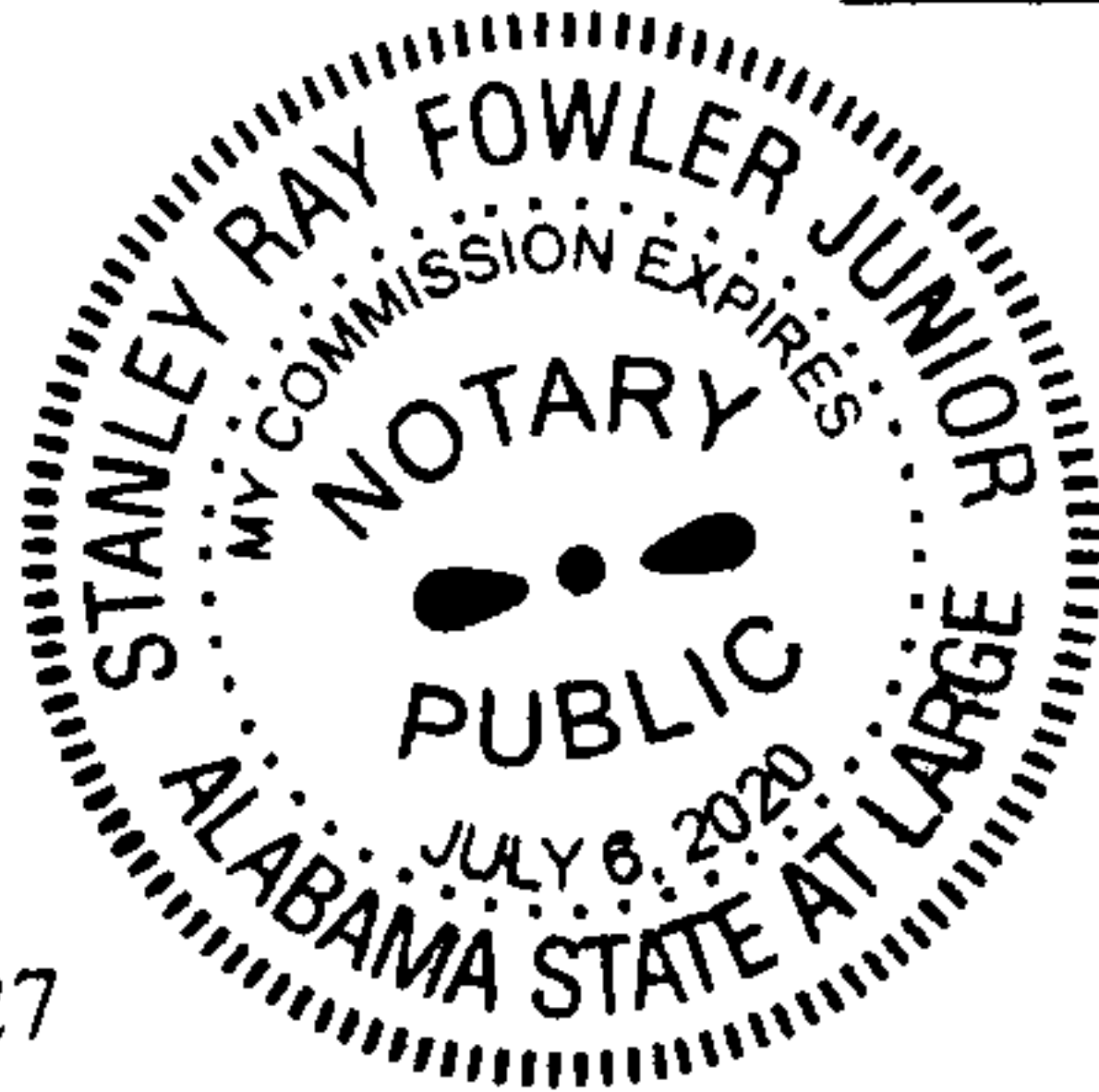
