TERMINATION OF SUBORDINATION AND ATTORNMENT AGREEMENT

This Termination of Subordination and Attornment Agreement is executed by ServisFirst Bank (the "Bank") this 1st day of February, 2019.

WHEREAS, a Mortgage was executed by Cole Properties, LLC and LACO Woodworks, Inc. (the "Mortgage") in favor of the Bank on June 15, 2012, covering the property at 100 Airpark Industrial Road, Alabaster, Alabama (the "Property"), which said Mortgage was recorded as Instrument No. 20120619000216630 in the office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, a Subordination Agreement was executed on June 15, 2012, by and between Laco Woodworks, Inc., as Tenant of the property (now "Former Tenant") and the Bank and recorded on June 19, 2012 as Instrument No. 20120619000216660 in the Office of the Judge of Probate of Shelby County, Alabama (the "Subordination Agreement"), which document subordinated the Lease between Cole Properties, LLC and the Former Tenant to the Mortgage; and

WHEREAS, the Bank foreclosed on said Mortgage and obtained a Mortgage Foreclosure Deed in the name of the Bank which was recorded on January 4, 2017 as Instrument No. 20170104000003070 and wherein the Bank became the owner of the Property; and

WHEREAS, as of the date of this termination, there was no longer a Mortgage on the Property on behalf of ServisFirst Bank and LACO Woodworks, Inc. is no longer a tenant of the Property; and

WHEREAS, the Subordination and Attornment Agreement is due to be terminated.

WHEREFORE, the Bank hereby terminates the Subordination and Attornment Agreement as of the date set out above.

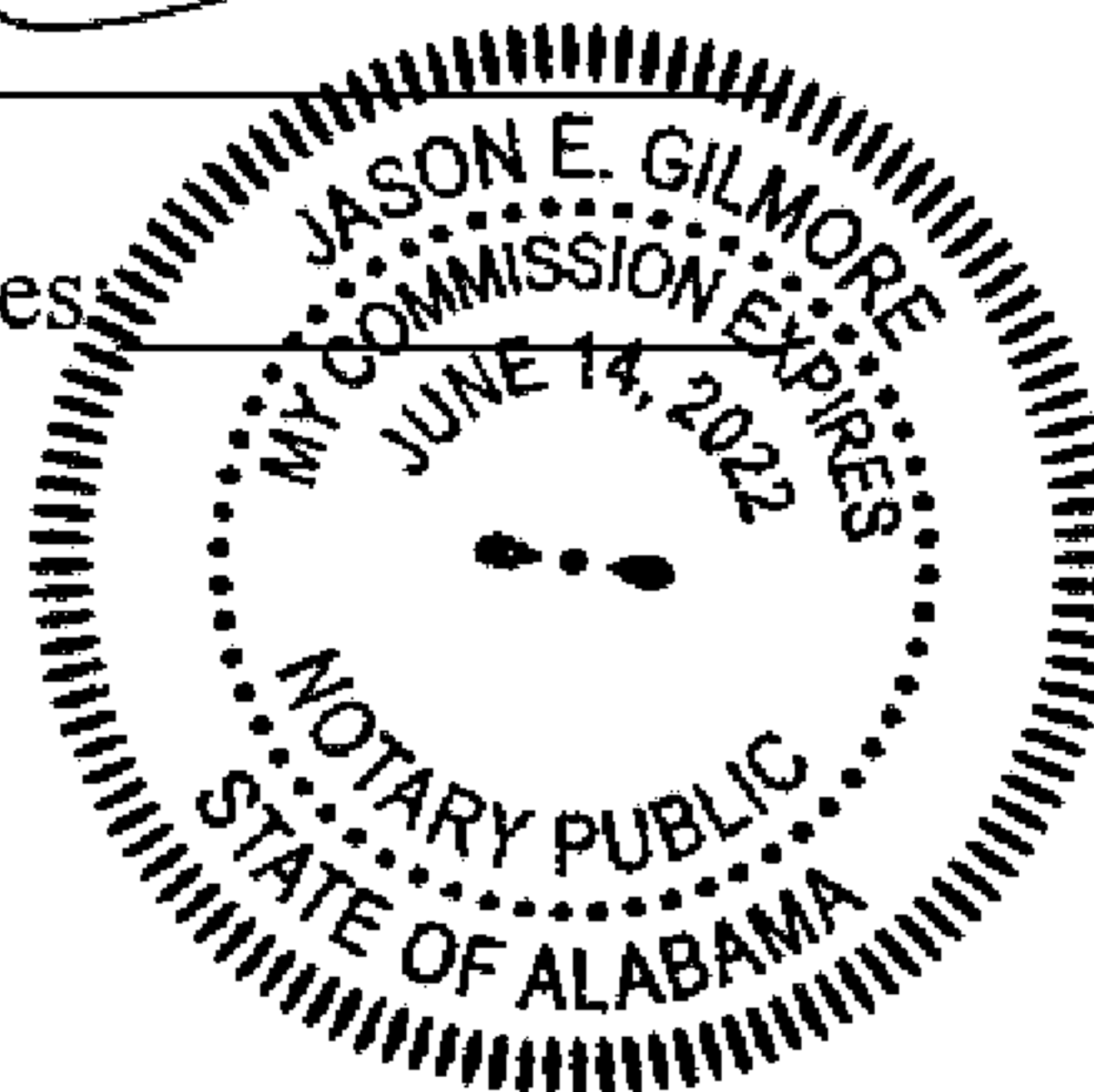
