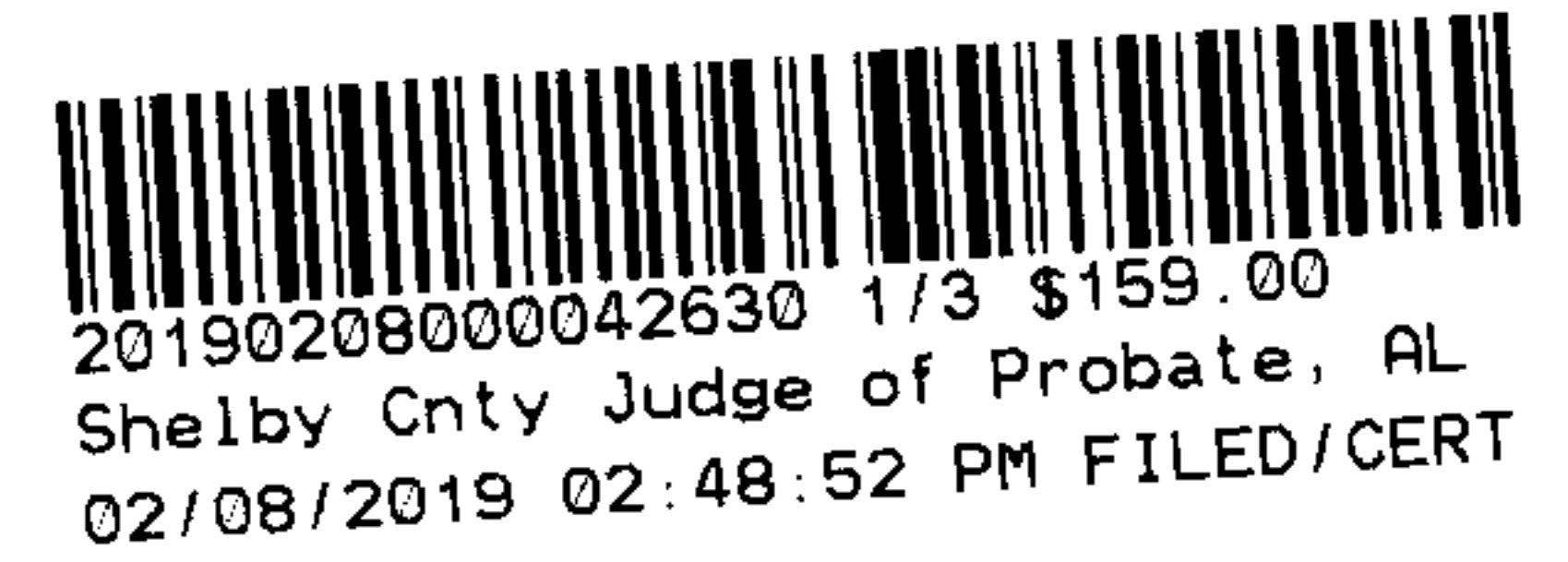

**CERTIFICATE OF FORMATION OF

The undersigned, desiring to become a Limited Liability Company for the purposes of carrying on the business hereinafter stated and set forth, do hereby make and file this Certificate of Formation pursuant to the provisions of the "Alabama Limited Liability Company Act" of Alabama, (Sections 10A-5-1, et seq., Code of Alabama 1975) and any amendments thereto, stating and certifying as follows:


