## LAST WILL AND TESTAMENT OF LARRY D. RAY

I, LARRY D. RAY, a resident of Shelby County, Alabama, declare this to be my Last Will and Testament. I revoke all prior Wills and Codicils that I have made.

## **ARTICLE I**

I specifically direct, however, that any debts that are payable in installments or are not due until at least one year following my death need not be paid in full during the administration of my estate, but may, if the terms of such debts permit, be continued and paid according to their tenure.

## **ARTICLE II**

I give, devise and bequeath all the rest, residue, and remainder of my estate, of whatever nature and wherever situated, of which I may be seized or possessed or to which I may be entitled at my death, including lapsed legacies and property over which I may have a power of appointment to my daughter, Shelby Nicole Ray.

## ARTICLE III

I appoint my daughter, Shelby Nicole Ray, as personal representative of this Will. I also appoint said personal representative as ancillary personal representative of my estate in any jurisdiction in which any part of my estate shall need to be administered. My personal representative shall serve without bond or surety and without being required to file any inventory or accounting of any kind with any court, and shall have all the powers and authority granted to personal representatives under the law of Alabama, it being my intention to give my personal representative the continuing, absolute and discretionary power to deal with my property, whether real or personal, held in my estate, as fully as I might in the handling of my own affairs, to be exercised independently and without prior approval of any court.
