Know All Men by These Presents: That in consideration of **Three Hundred Sixty-Eight Thousand Nine Hundred and no/100 Dollars (\$368,900.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is acknowledged, **CARLISLE CREEK CONSTRUCTION, LLC** (herein referred to as Grantor) does hereby grant, bargain, sell and convey unto **STEPHEN MITCHELL JONES, II and DOMINI L. 
