That in consideration of the sum of **One Hundred Eighty Five Thousand Dollars and No Cents (\$185,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Eddie R. Absher, a single man** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Amanda Welch and William Welch,,** (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama; to wit;

Lot 4, Sector A, According to the Survey of The Homestead as recorded in Map Book 8, Page 167 in the Probate Office of Shelby County, Alabama.

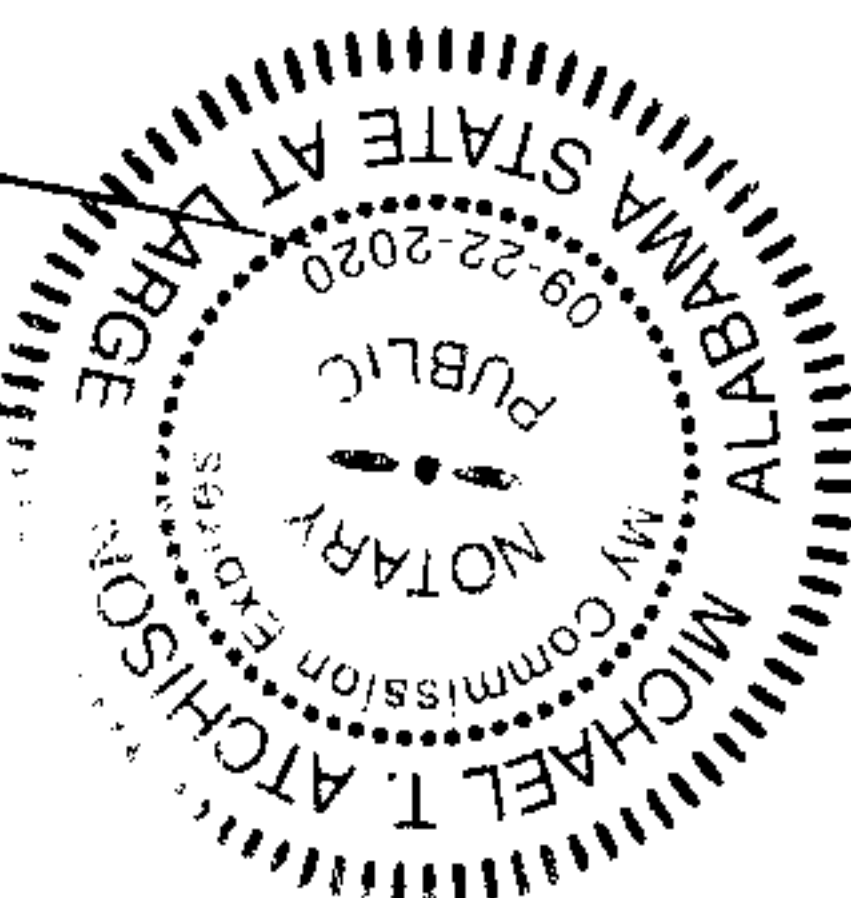
