

**MORTGAGE FORECLOSURE DEED**

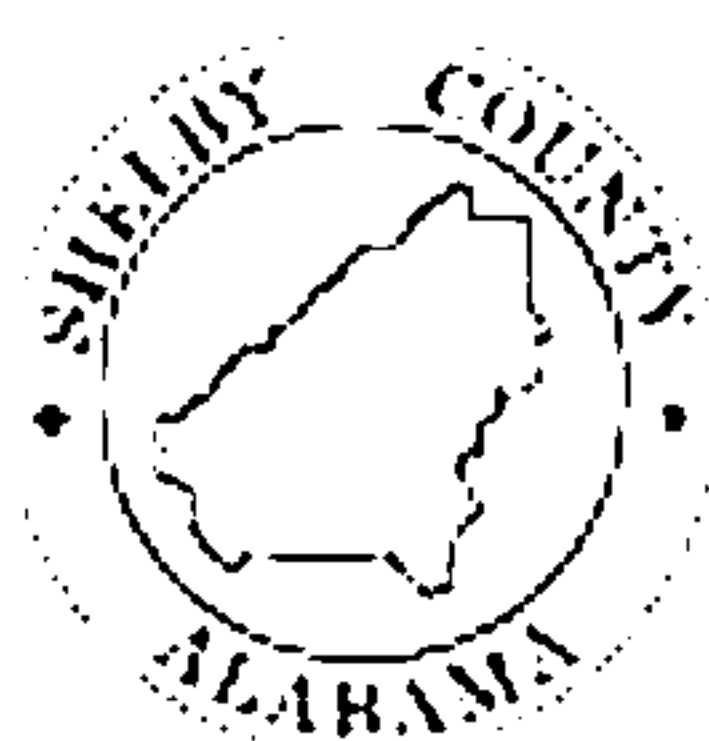
