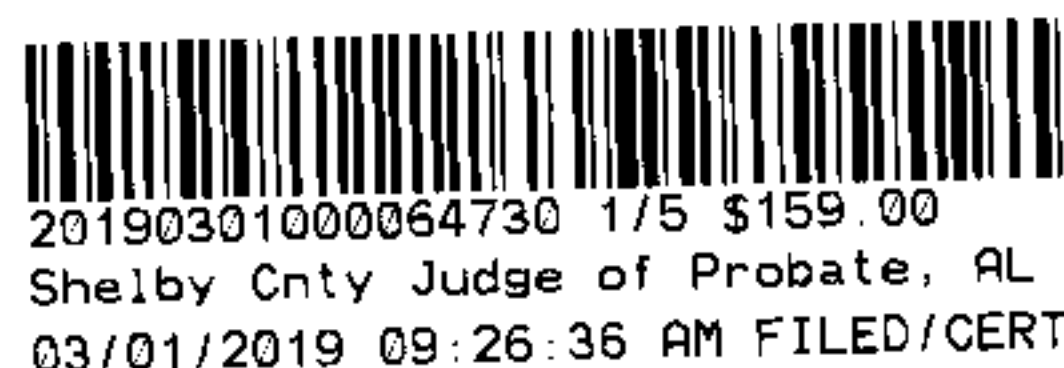
ARTICLE II – PURPOSE:

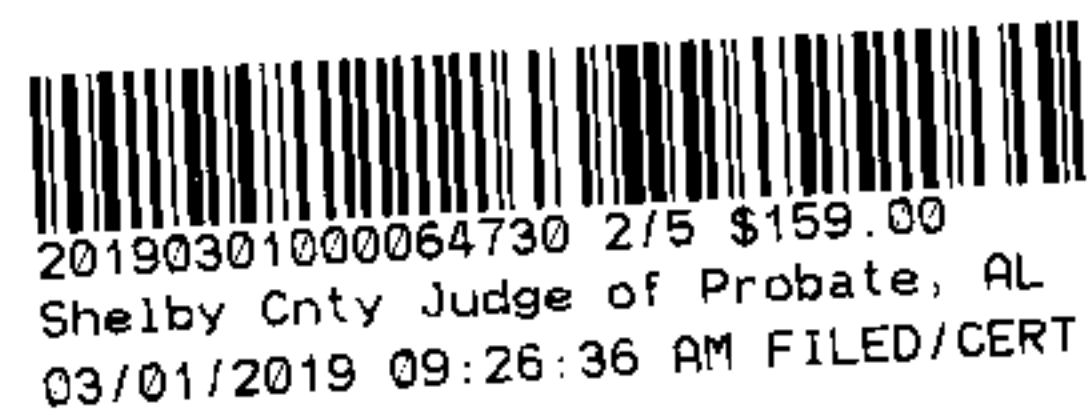

New members can be admitted to the company with full rights of membership upon the unanimous consent of the existing members.

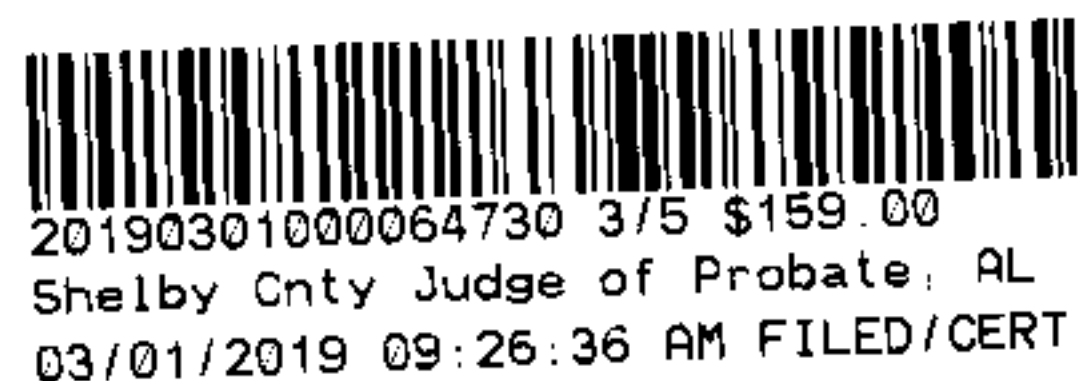
