KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Two Hundred Twenty-Nine Thousand Nine Hundred Dollars and NO/100 (\$229,900.00)** to the undersigned grantors, in hand paid by the grantees herein, the receipt whereof is acknowledged, we, **Frederick G. Evans and Tonia Davis Evans, husband and wife**, (herein referred to as grantors), grant, sell, bargain and convey unto, **Clarence John Thompson and Jackie Sue Thompson** (herein referred to as grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

Lot 81, according to the Final Plat of Narrows Point-Phase 5, as recorded in Map Book 35, at Page 90 A & B, in the Office of the Judge of Probate of Shelby County, Alabama.

Together with the nonexclusive easement to use the Common Areas as more particularly described in The Narrows Residential Declaration of Covenants, Conditions and Restrictions recorded as Instrument No. 2000-09755, as amended by instruments recorded as Instrument No. 2000-17136, Instrument No. 2000-36696, Instrument No. 2001-38328, Instrument No. 20020905000424180, Instrument No. 20021017000508250, and Instrument No. 20030716000450980, and Instrument No. 20050831000450840, all recorded in the Probate Office of Shelby County, Alabama (which, together with all amendments thereto, is hereinafter collectively referred to as the "Declaration").

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

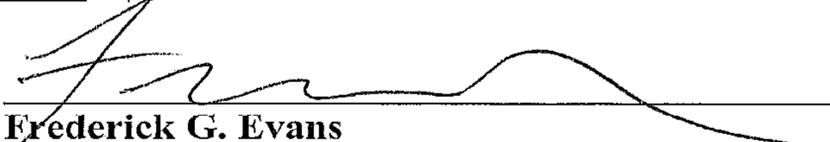
\$ 183,900 of the above consideration was secured by and through a purchase money mortgage closed herewith.

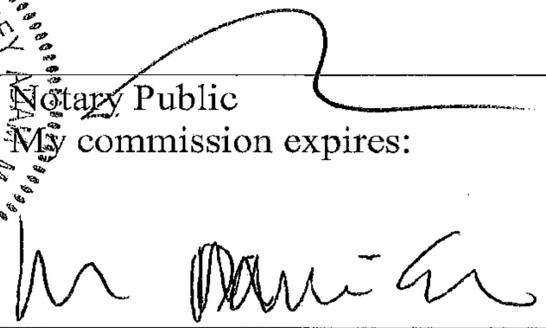

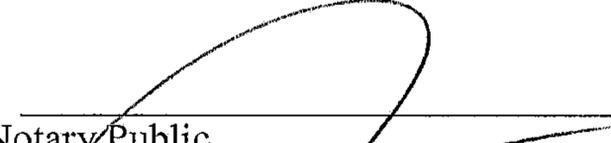
