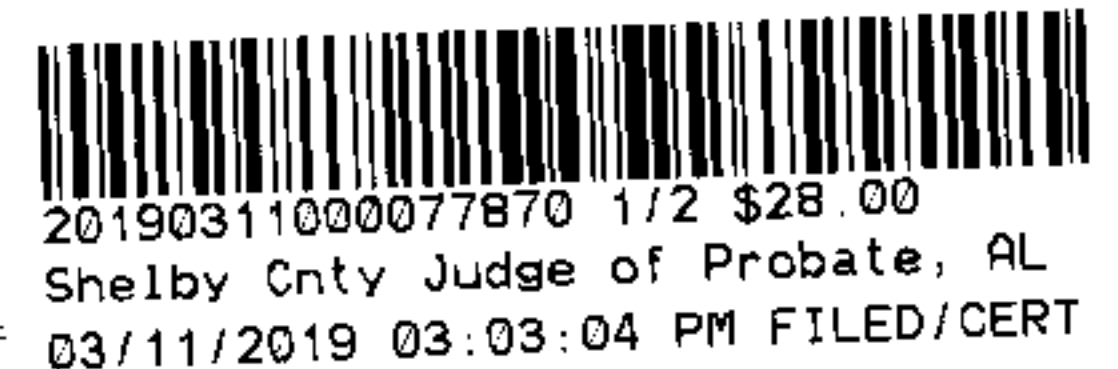

(herein referred to as Grantor, whether one or more), grants, bargains, sells, and conveys unto

ANH DAO NGUYEN LE, TRUSTEE, OR HER SUCCESSORS IN TRUST, UNDER THE NGUYEN LE LIVING TRUST, DATED FEBRUARY 27, 2019, AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

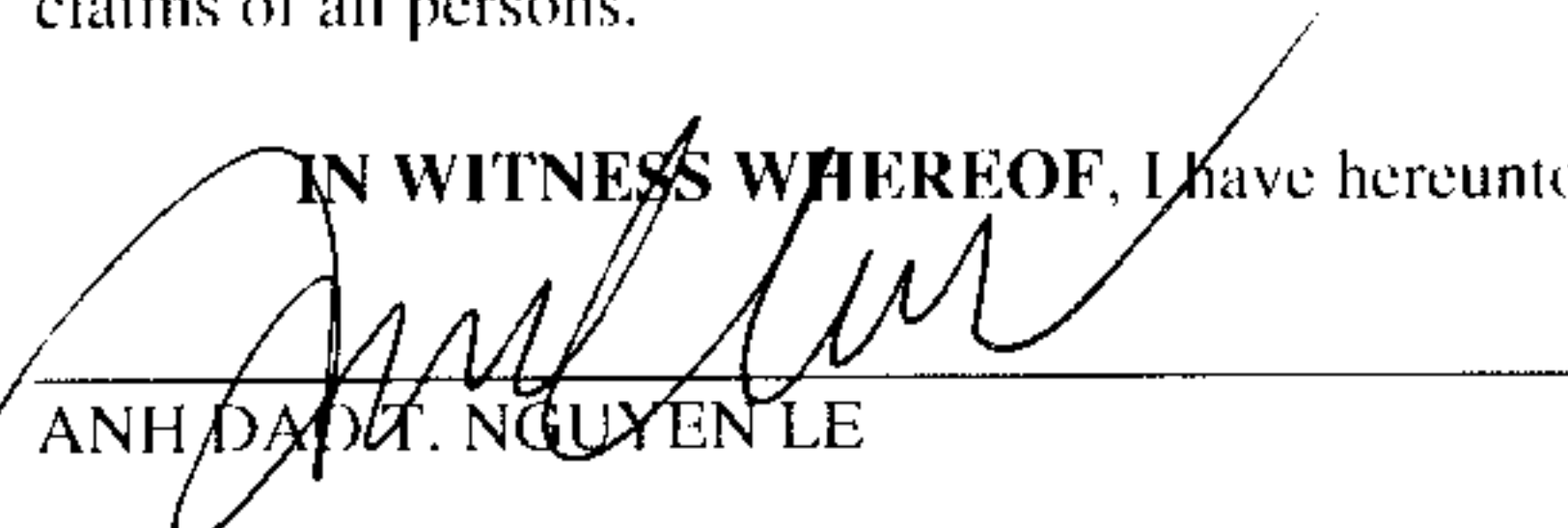
Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

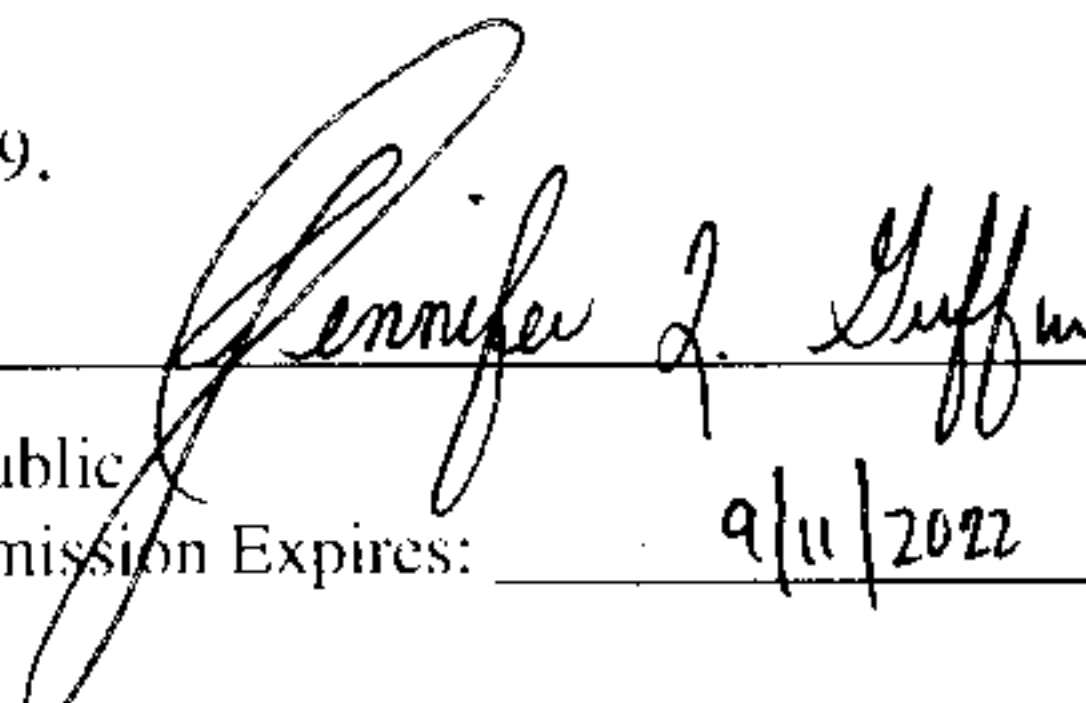

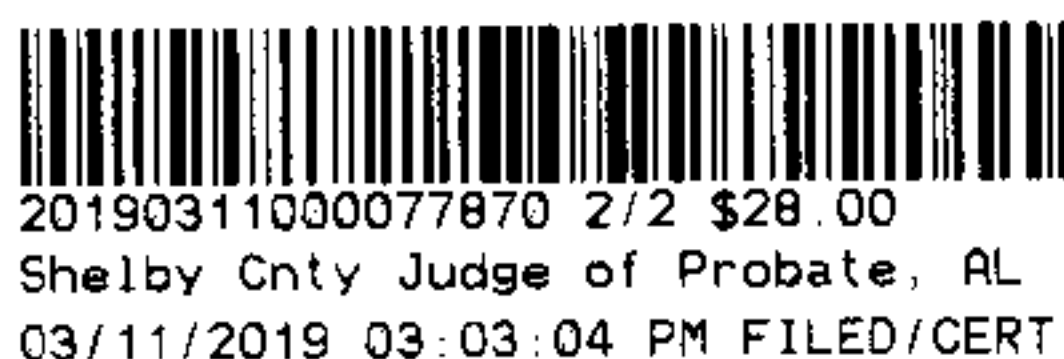
