\$405,445.00 of the purchase price recited herein was paid from the proceeds of a purchase money mortgage closed simultaneously herewith.




1. Ad valorem taxes for the current tax year.

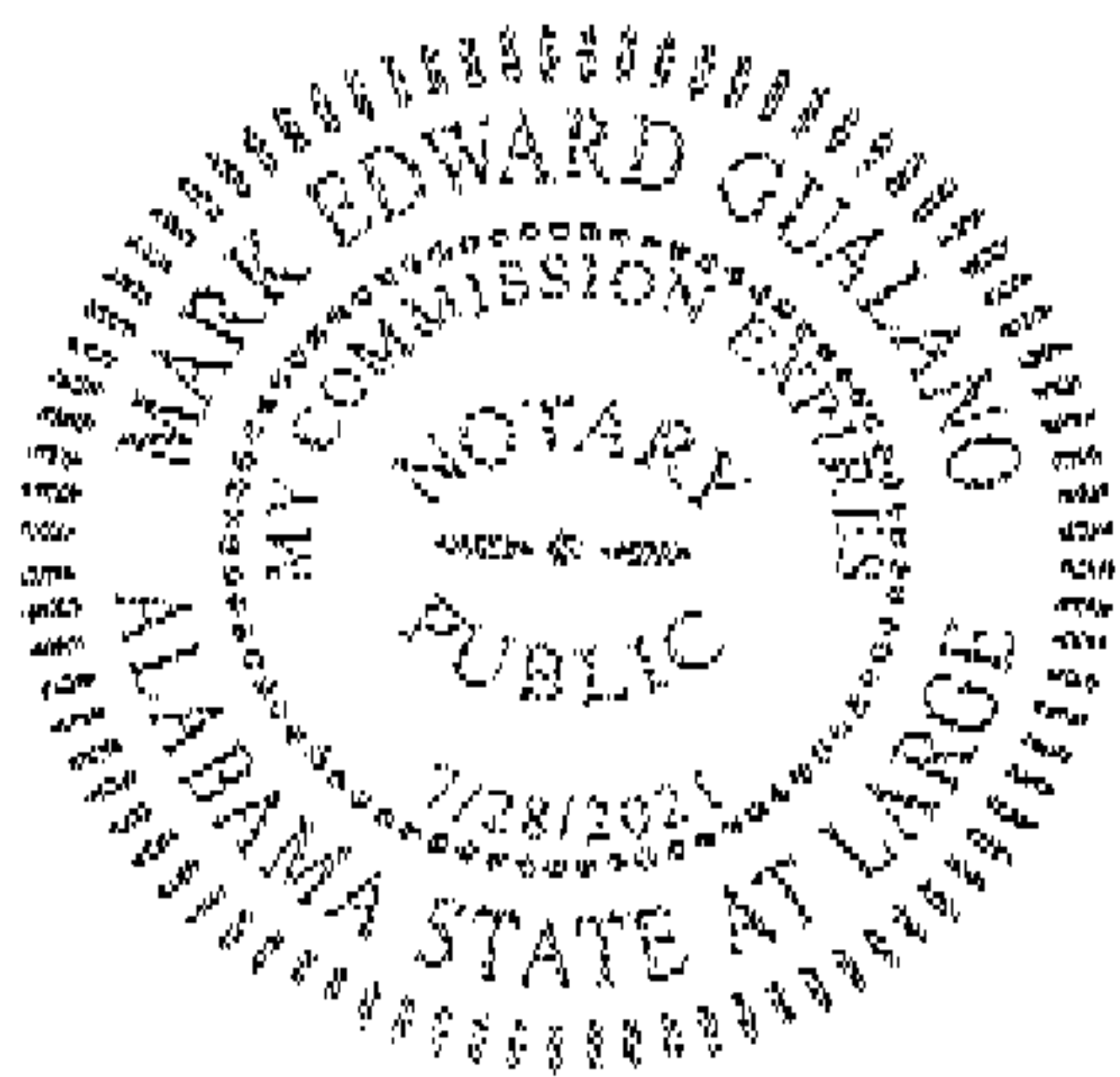


