

ORDINANCE NO. <u>18-2416</u>

Shelby Cnty Judge of Probate, AL 03/13/2019 09:11:03 AM FILED/CERT

An ordinance to alter, rearrange and extend the corporate limits of the City of Hoover, Alabama, so as to embrace and include within the corporate limits of said City all territory now within such corporate limits and also certain other territory contiguous to said City.

WHEREAS, a petition signed by <u>Hoover City Board of Education</u> requesting that certain territory described therein be annexed to the City of Hoover, and

WHEREAS, there is attached to the said petition a map of said territory showing its relationship to the corporate limits of the City; and

WHEREAS, this Council has determined and found that the matters set forth and alleged in the said petition are true and that it is in the public interest that said property be annexed into the City of Hoover;

NOW, THEREFORE, be it ordained by the Council of the City of Hoover as follows:

SECTION 1: That said Council hereby assents to the annexation of said territory to the City of Hoover, Alabama, and the corporate limits of the City of Hoover are hereby extended and rearranged pursuant to the provisions of Chapter 42, Article 2, Code of Alabama, 1975 (Sections 11-42-20 through 11-42-23, as amended) so as to embrace and include said territory, in addition to the territory already within its present corporate limits, within the corporate area of said City, which said territory is not within the corporate limits or municipal boundaries of another municipality and does not lie at any point more than one-half the distance between the present corporate limits or municipality and does not lie at any point more than one-half the distance between the present corporate limits and the corporate limits of any other municipality. Said property is described in Exhibit "A" attached hereto and made a part hereof.

SECTION 2: The City Clerk shall file a certified copy of this ordinance containing an accurate description of said annexed territory with the Probate Judge of Shelby County, Alabama, and publish a copy of this ordinance as required by state law.

Legal Description

Annexation – Phase 6

A tract of land situated in the South Half of the Southwest Quarter, and the Northeast Quarter of the Southwest Quarter of Section 25, Township 19 South, Range 03 West, Shelby County, Alabama and being more particularly described as follows:

COMMENCE at the Southwest corner of Section 25;

Thence South 88°57'25" East a distance of 238.03 feet along the South line of said section;

Thence North 01°08'57" East for a distance of 538.51 feet;

Thence North 60°12'04" East for a distance of 215.19 feet;

Thence North 51°35'57" East for a distance of 240.96 feet;

Thence North 70°06'13" East for a distance of 276.64 feet;

Thence North 63°10'16" East for a distance of 959.53 feet;

Thence South 80°58'29" East for a distance of 227.99 feet to a point on the Pelham City Limit;


Thence South 00°37'05" East along said city limit for a distance of 1233.30 feet to the **POINT OF BEGINNING**;

Thence continuing South 00°37'05" East along said city limit for a distance of 82.80 feet;


Thence North 89°00'45" West for a distance of 45.72 feet along South line of said section;


