Registered Office; Registered Agent**

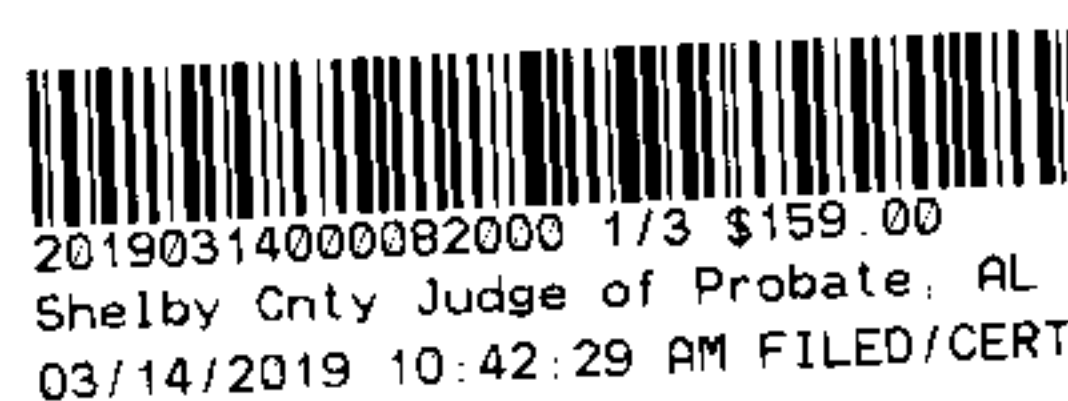
