Your filing will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored (\$30.00 fee).

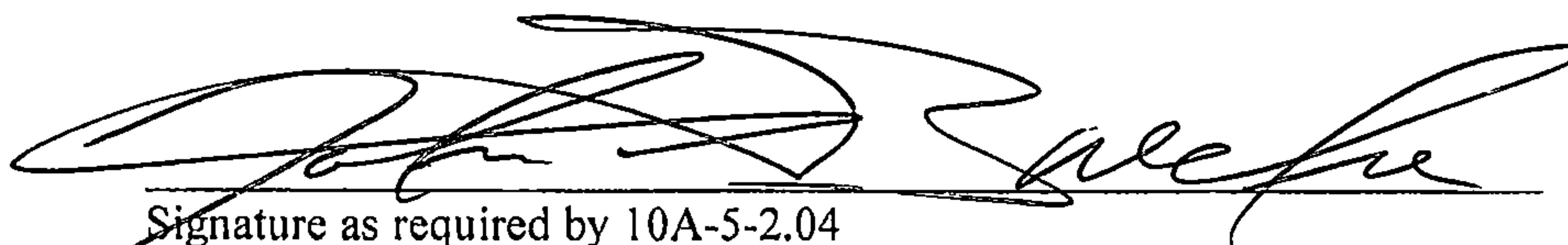

NOW THEREFORE, the Members of the Company hereby adopt the following resolutions:

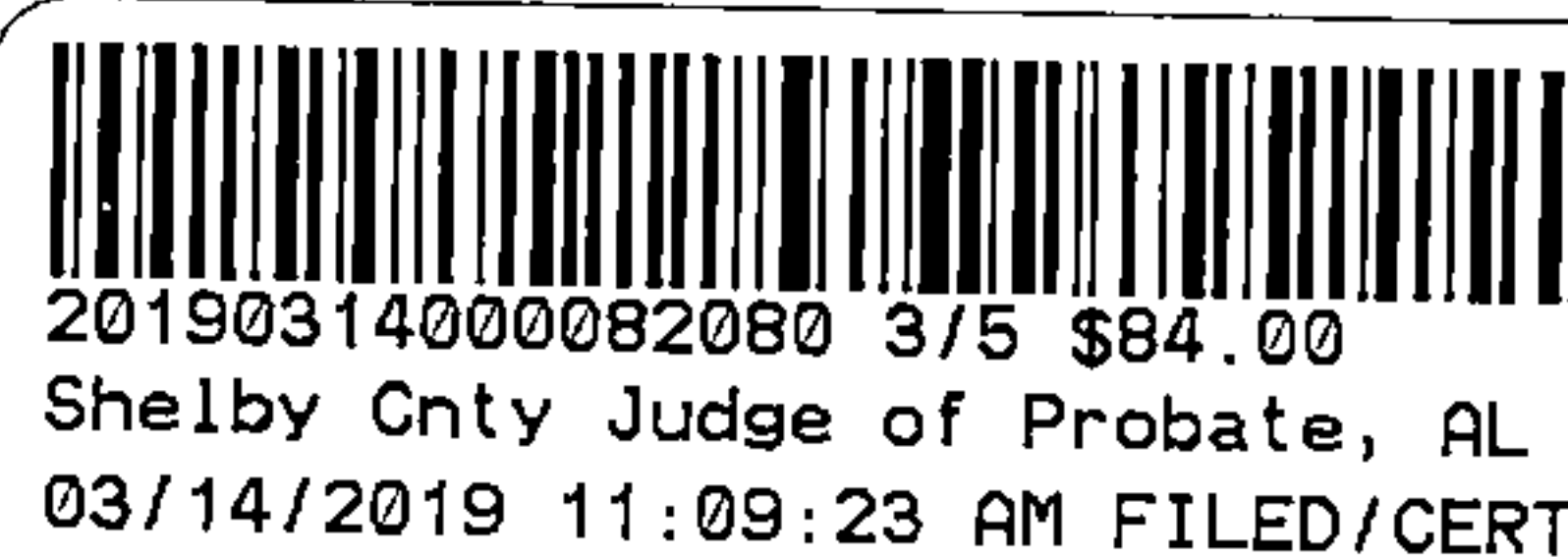
