KNOW ALL MEN BY THESE PRESENTS,

On this March 14, 2019, That for and in consideration of **ONE HUNDRED FORTY ONE THOUSAND AND NO/100 (\$141,000.00) DOLLARS,** and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **ANNA WILBANKS (WHO IS ONE AND THE SAME PERSON FORMERLY KNOWN AS ANNA S. BURTON), a married person,** (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **JAG INVESTMENT STRATEGIES, LLC,** (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA,** to wit:

Lot 32, according to the Survey of Cottages at Chesser, Phase 1, recorded in Map Book 33, Page 45, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama (the "property").

Together with the nonexclusive easement to use the Common Areas as more particularly described in The Chesser Plantation Declaration of Covenants, Conditions, and Restrictions recorded as Inst. #2002-10788 in the Probate Office of Shelby County, Alabama (which, together with all amendments thereto, is hereinafter collectively referred to as the "Declaration").
