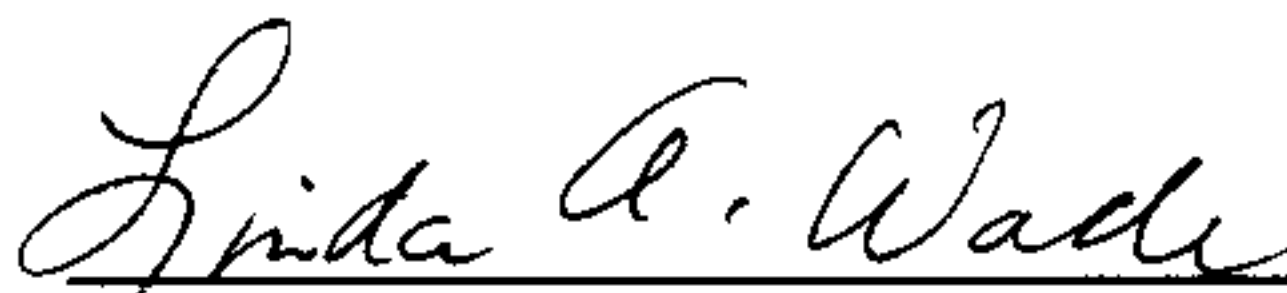
For ad valorem tax purposes only, the address for the above described property is 232 Appleford Road, Helena, AL 35080.

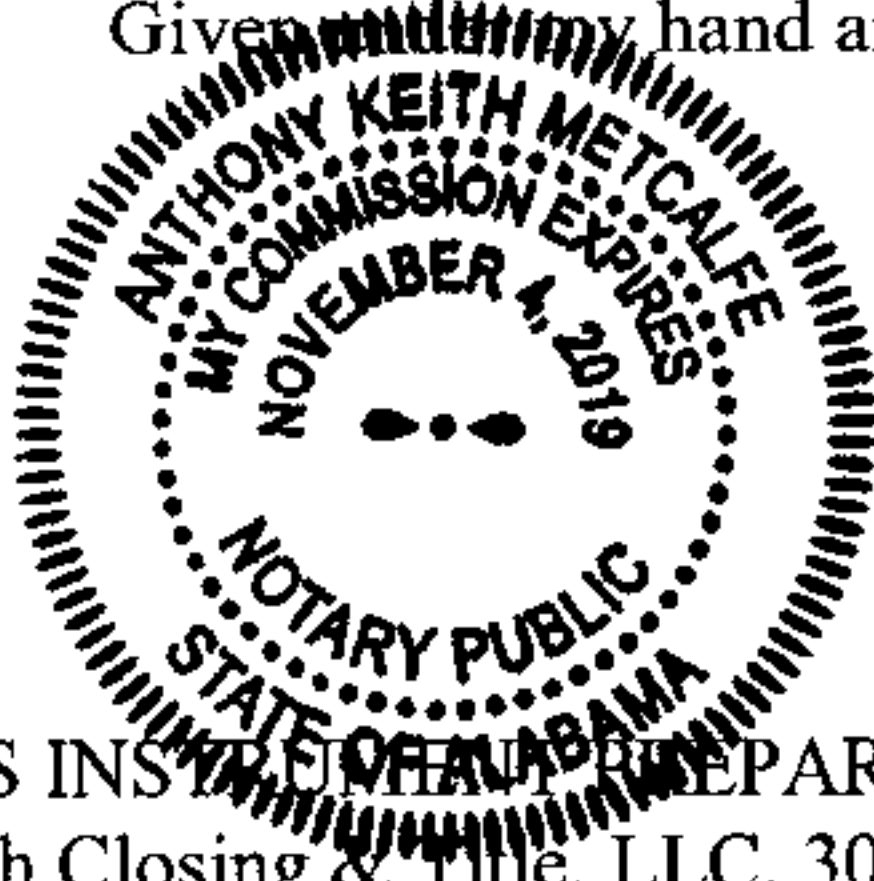

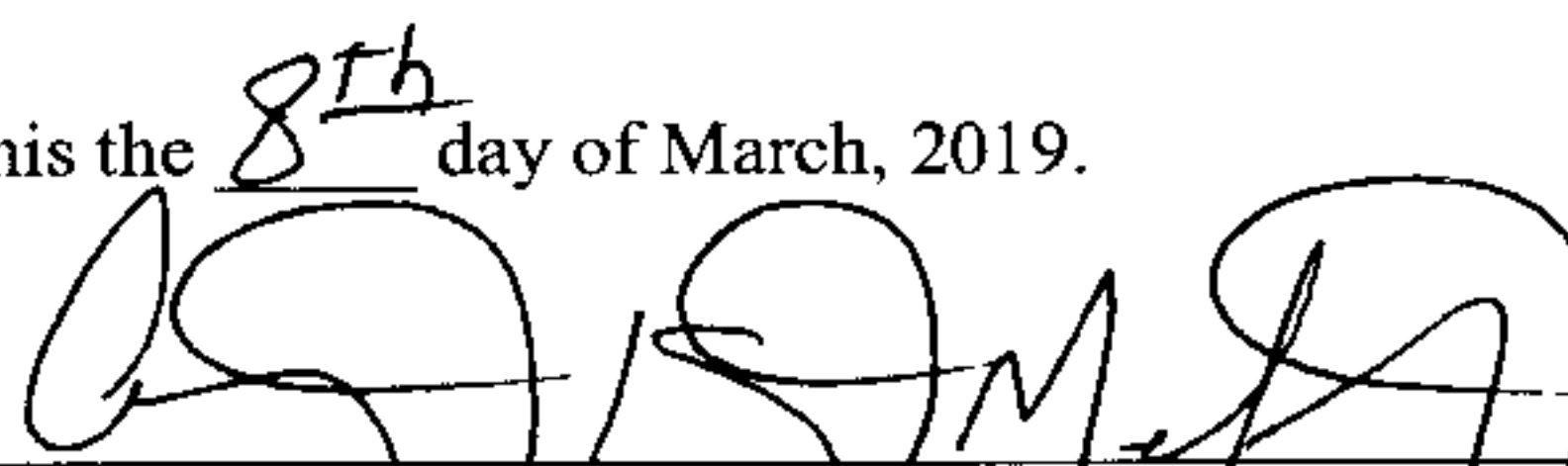
