

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of February, 2007, Donald T. McAuliffe and Kimberly J. McAuliffe, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for HSBC Mortgage Corporation (USA), which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20070305000096870 said mortgage having subsequently been transferred and assigned to Deutsche Bank National Trust Company, Trustee Mortgage Pass Through Certificates, Series 2007-1, by that instrument recorded in Instrument No. 20180731000272490 in the aforesaid Probate Office ("Transferee"); and
