

#### ITEM VII



It is my intention that the above mentioned grandchildren receive absolutely nothing from my estate, nor should their heirs, assigns or descendents.

### ITEM VIII

I nominate, constitute and appoint my daughter, Janet Elaine Turner Atkins, to be the Executor of this my Last Will and Testament and direct that she shall not be required to give bond or to file an inventory or appraisal of my estate or to make an accounting or final settlement or any report to any court. In the event that Janet Elaine Turner Atkins shall predecease me or fail for any reason to qualify as Executor hereunder, I nominate, constitute and appoint my son, Alfred Isaac Turner, as Executor of this my Last Will and Testament and direct that he shall not be required to file an inventory or appraisal of my estate or to make an accounting or final settlement or any report to any court. In the event that

Alfred Isaac Turner shall predecease me or fail for any reason to qualify as Executor hereunder, I nominate, constitute and appoint my niece, Wanda Bramlett, as Executor of this my Last Will and Testament and direct that she shall not be required to file an inventory or appraisal of my estate or to make an accounting or final settlement or any report to any court. During the administration of my estate I hereby vest in my Executor free from the control and supervision of any court, such powers of management, control and disposition as are given above.

#### ITEM IX

It is my desire that this, my Last Will and Testament, establish a Testamentary Trust for the benefit of my granddaughter Emily Madison Jett, born on or about March 30th, 2007. Any property, assets or other distributions from my estate intended for Emily Madison Jett shall not be paid or distributed outright to such beneficiary but shall instead be held in trust by my Trustee, or if I have not named a Trustee, by my Executor in the capacity of a Trustee, upon the following terms and conditions.

FORMATION: The Trustee shall hold, manage, invest and reinvest the property of such beneficiary in a separate trust and shall distribute to or for the benefit of the beneficiary so much or all of the net income or principal thereof as the Trustee shall deem necessary to provide for such beneficiary's health, education, maintenance and support, taking into consideration any other resources available to such beneficiary. Any net income not so paid shall be accumulated and added to principal at least annually and thereafter shall be held, administered and disposed of as a part thereof.

DISTRIBUTION: When such beneficiary reaches 18 (eight-teen) years of age, the Trustee shall distribute up to but no more than \$20,000 per year for use in the education and support of the beneficiary; and if and when such beneficiary reaches 25 (twenty-five) years of age, the Trust shall automatically terminate and the Trustee shall distribute all remaining principal and income to such beneficiary. If my Trustee sees fit to terminate the Trust before the beneficiary turns 25 (twenty-five) they may do so only if the beneficiary has graduated college. The Trustee may do so with no liability.


The Trustee, at their discretion, may distribute an amount not to exceed \$10,000 (not inclusive of taxes and fees) upon the beneficiary turning 16 (six-teen) for the sole purpose of providing an automobile to the beneficiary.

If such beneficiary dies before receiving all of the assets in her trust, the principal and income in such beneficiary's trust shall be paid and distributed to Leah Caroline Atkins Nelson and Mary Elizabeth Atkins Jett, equally. If I have no living descendant, such property shall be distributed to the beneficiaries of my residuary estate as provided in this Will, or if there are none, to the persons who would be entitled thereto under the laws of descent and distribution of the State of Alabama if I had died intestate at that time owning such property in fee simple.




