MODIFICATION OF MORTGAGE

Notice: This Modification of Mortgage does not secure new indebtedness or an increased amount of debt under the Note (as defined below).

THIS MODIFICATION OF MORTGAGE dated December 27, 2018, is made and executed between Trustees for Ward Chapel A.M.E. Church at Montevallo, Alabama (referred to below as "Grantor") and Trustmark National Bank, whose address is 835 Main Street, Montevallo, AL 35115 (referred to below as "Lender").

MORTGAGE. The Peoples Bank and Trust Company and Grantor have entered into a Mortgage dated February 24, 2006 (the "Mortgage") which has been recorded in Shelby County, State of Alabama, as follows:

Mortgage and Security Agreement dated February 24, 2006, recorded March 15, 2006 in Instrument Number 20060315000121490 in the Office of the Judge of Probate, Shelby County, Alabama, and modified by Modification of Mortgage dated December 11, 2013, recorded in said records in Instrument Number 20140116000015830.

Lender is the successor in interest to The Peoples Bank and Trust Company pursuant to the following transactions:

The Peoples Bank and Trust Company merged with and into BankTrust by merger agreement filed in the Alabama Secretary of State's office on December 11, 2007, effective on December 14, 2007.

BankTrust was subsequently merged with and into Trustmark National Bank, Jackson, MS, according to that certain Agreement and Plan of Merger of BankTrust with and into Trustmark National Bank which was recorded in the Alabama Secretary of State's office on February 11, 2013.

AND

BankTrust and Grantor entered into a Mortgage dated August 8, 2008 (the "Mortgage") which has been recorded in Shelby County, State of Alabama as follows:

Real Estate Mortgage dated August 8, 2008 recorded August 11, 2008 in Instrument Number 20080811000322070 in the Office of the Judge of Probate, Shelby County, Alabama, and modified by Modification of Mortgage dated December 11, 2013, recorded in said records in Instrument Number 20140116000015830.

Lender is the successor in interest to BankTrust pursuant to the following transaction:

BankTrust merged with and into Trustmark National Bank by virtue of that certain Agreement and Plan of Merger of BankTrust with and into Trustmark National Bank which was recorded in the Alabama Secretary of State's office on February 11, 2013.

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

The parcel of real property being more particularly described in the attached EXHIBIT "A", shall be modified to add Parcel No. 27-8-28-2-201-007.00.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.


