

Articles of Organization

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

Pursuant to the provisions of the Alabama Limited Liability Company Act (hereinafter referred to as "the Act") the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I

NAME

The name shall be P.M.J. Enterprise LLC.

ARTICLE II

DURATION

Unless it is dissolved and its affairs wound up prior to the date (a) upon the writing of all members; (b) as provided in the Operating Agreement, or (c) as may be required by the Act, the Company shall have perpetual duration and succession in its name beginning on the date these Articles are filed with the Judge of Probate.

ARTICLE III

EFFECTIVE DATE

The filing of the limited liability company is effective immediately on the date filed by the Judge of Probate.

ARTICLE IV

INITIAL REGISTERED OFFICE

The location and mailing address of the initial registered office of the Company is 1012 Dunnivant PL. Birmingham, AL 35242.

INITIAL REGISTERED AGENT

The name of the initial registered agent of the Company at such address is Paul Maxey Jackson.

ARTICLE V

MEMBERS

ARTICLE VI

CESSATION OF MEMBERSHIP

The cessation of membership of one or more members will not result in dissolution of the company.

ARTICLE VII

POWERS

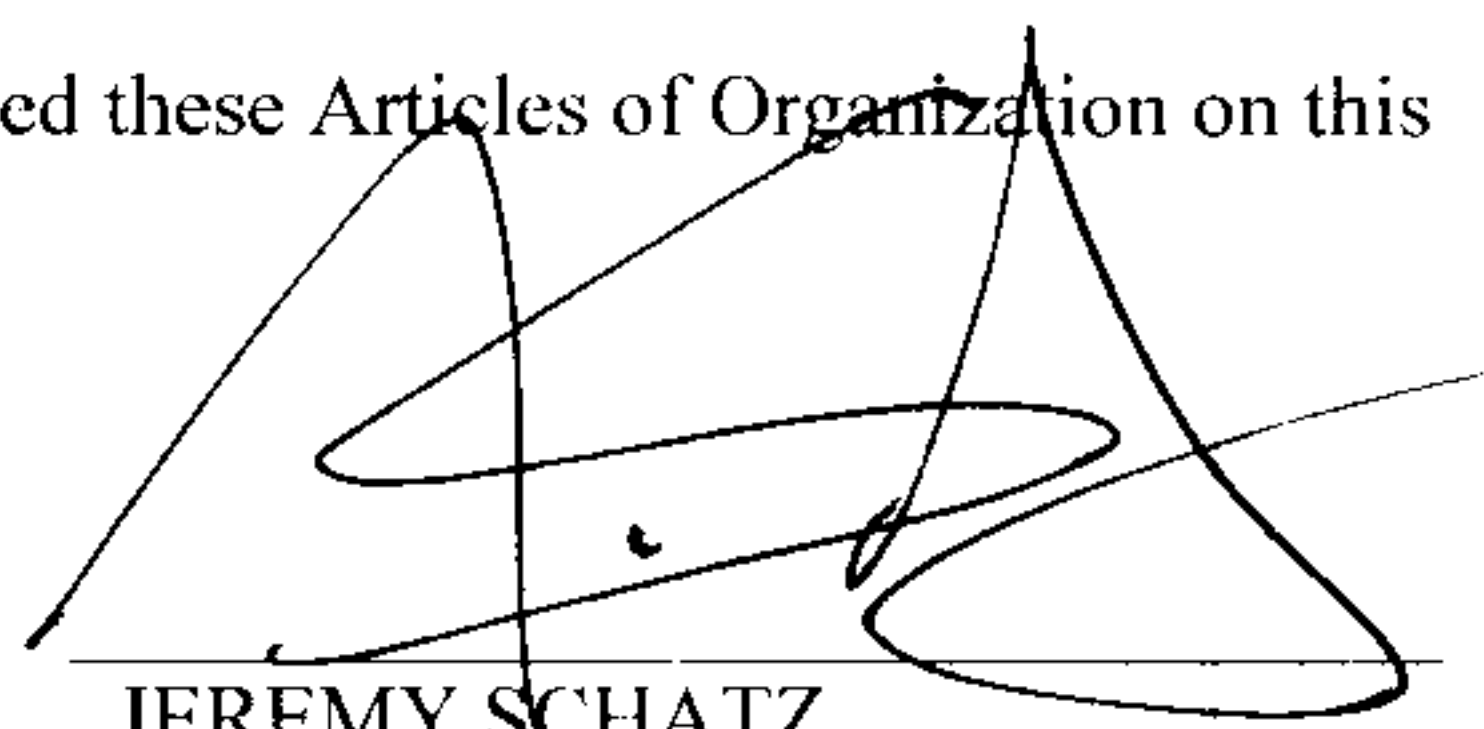
