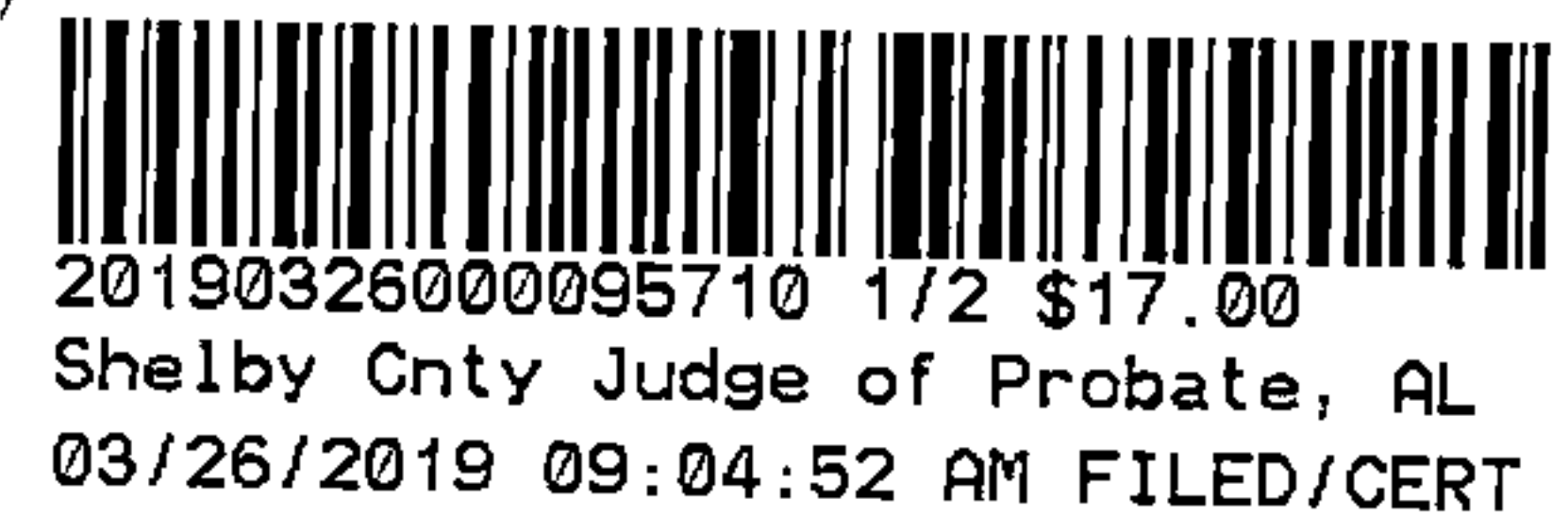

**CERTIFICATION OF TRUST

 - A. The original settlor(s) and successor settlor(s), if any, of the trust are John J. Brown and Corinne B. Brown.
 - B. The following person(s) contributed money, funds, real property, or personal property to the trust: John J. Brown and Corinne B. Brown
 - C. John J. Brown died on or about May 30, 2018 and Corinne B. Brown died on or about December 31, 2018. Neither estate required probate.

3. The John J. Brown and Corinne B. Brown Living Trust has a definite beneficiary. The same person is not the sole trustee and sole beneficiary.
4. The administrative and/or managerial powers of the trustee are general trustee powers under Alabama law, including, but not limited to, the power to sell, pledge, mortgage, transfer, convert or otherwise dispose of, or grant any of the property of the trusts....and to execute and deliver any mortgages, deed or deeds (with or without warranty)...in connection with any of his [or her] powers.
5. The trust is Irrevocable.

 - A. The following trustee(s) have the authority to sign documents and instruments: Gary Brown
 - B. Only one trustee is required to sign documents on behalf of the trust.

7. Third parties are entitled to rely on the authority of the successor trustee(s) without proof of his/her/their succession.
