Lot 48, according to the Map of Southern Hills, as recorded in Map Book 7 Page 72, in the Probate Judge's Office of Shelby County, Alabama.





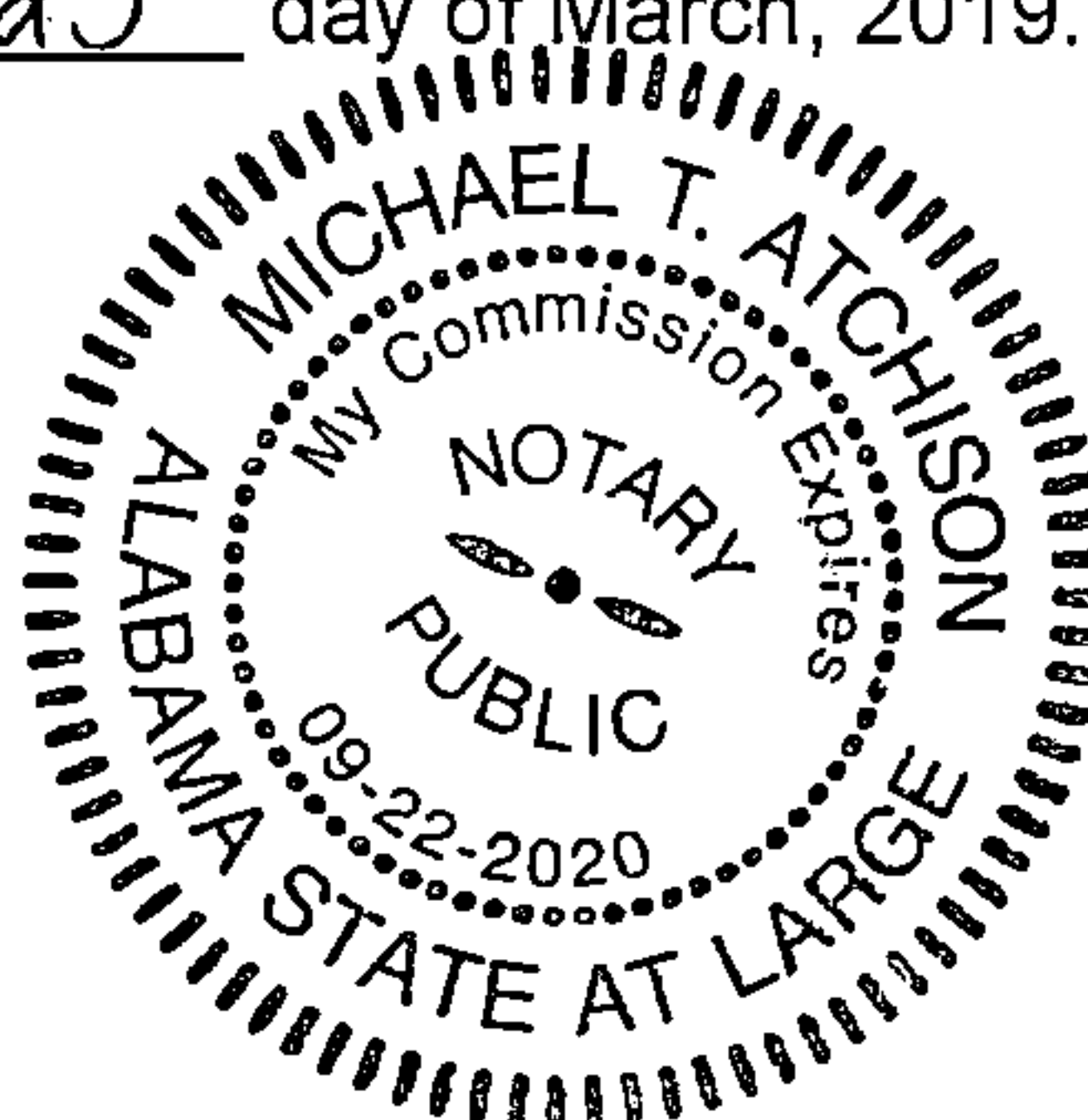
