STATUTORY WARRANTY DEED WITH RIGHT OF SURVIVORSHIP

That in consideration of Three Hundred Sixty Three Thousand Six Hundred Fourteen Dollars and No Cents (\$363,614.00) to the undersigned Grantor, Newcastle Construction, Inc., an Alabama Corporation, (herein referred to as Grantor) in hand paid by the Grantees, herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto William Bart Davis and Jillian J. Davis (herein referred to as Grantees), as joint tenants, with right of survivorship the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 133, according to the Survey of Hillsboro Subdivison Phase III, as recorded in Map Book 39, Page 123 A, B and C, in the Probate Office of SHELBY County, ALABAMA.

Subject to: All easements, restrictions and rights of way of record.


\$345,433.00 of the above mentioned purchase price was paid for from a mortgage loan which was closed simultaneously herewith.



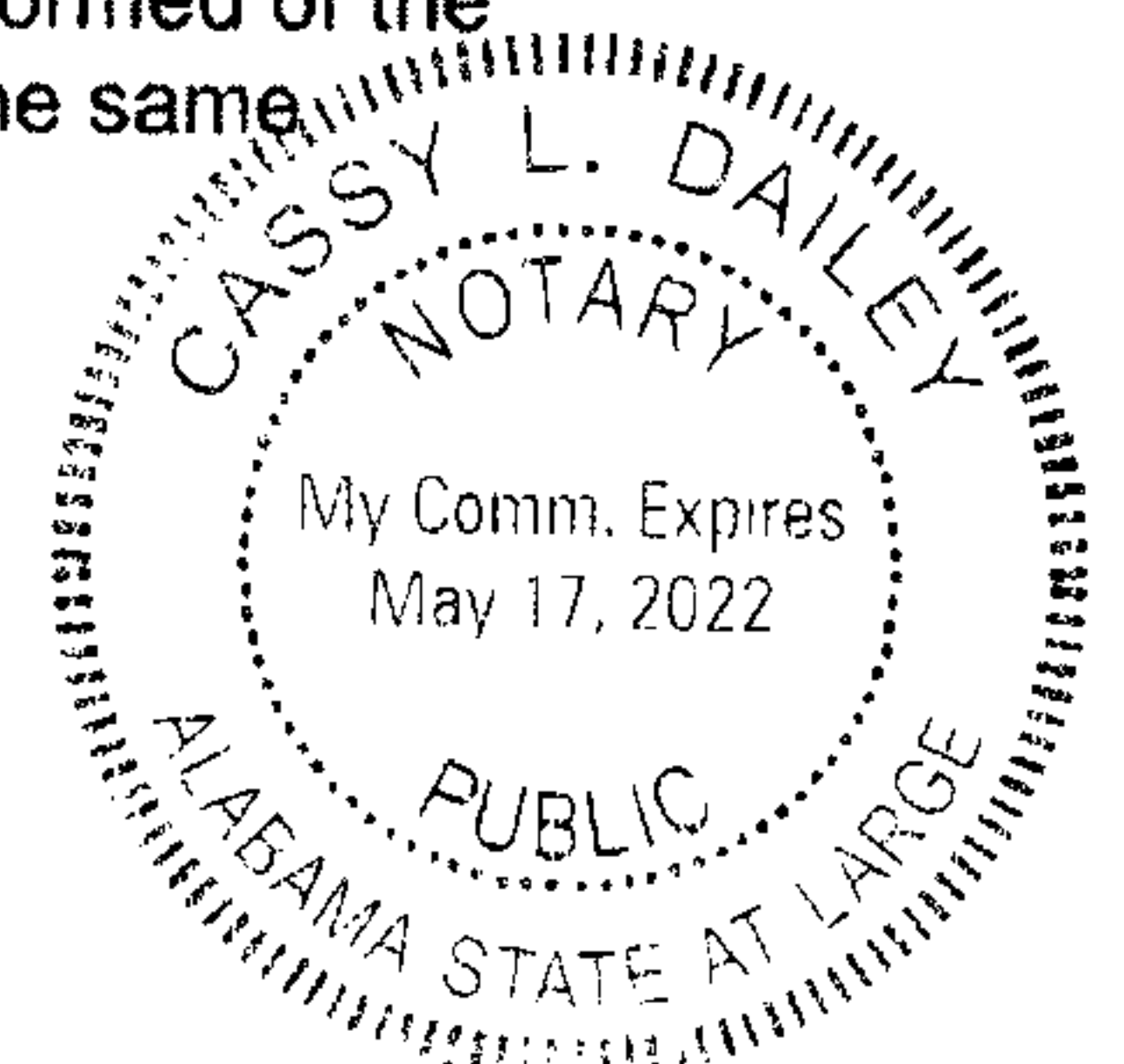
