(herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Anthony C. Thompson and Sherry S. Thompson
(herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **SHELBY** County, Alabama, to-wit:

Lot 335, according to the Survey of The Reserve at Timberline Sector 4 Phase One, as recorded in Map Book 47, Page 97 A & B, in the Probate Office of Shelby County, Alabama.

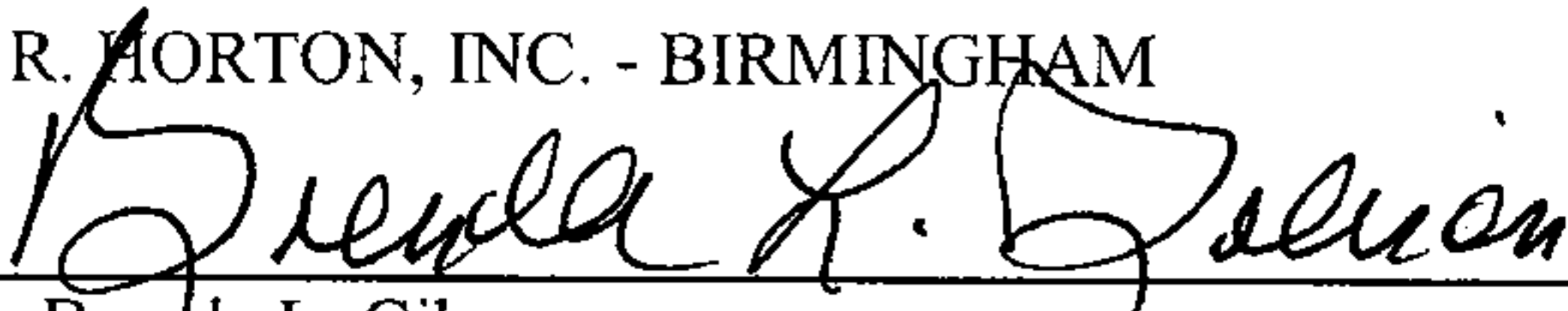

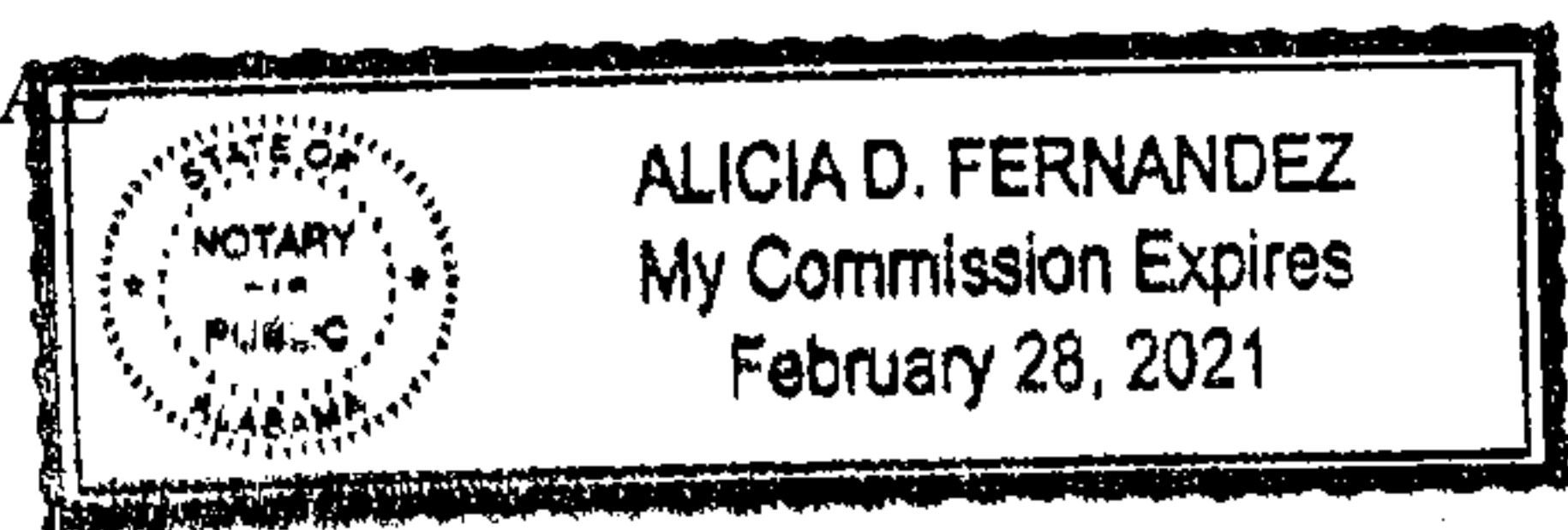

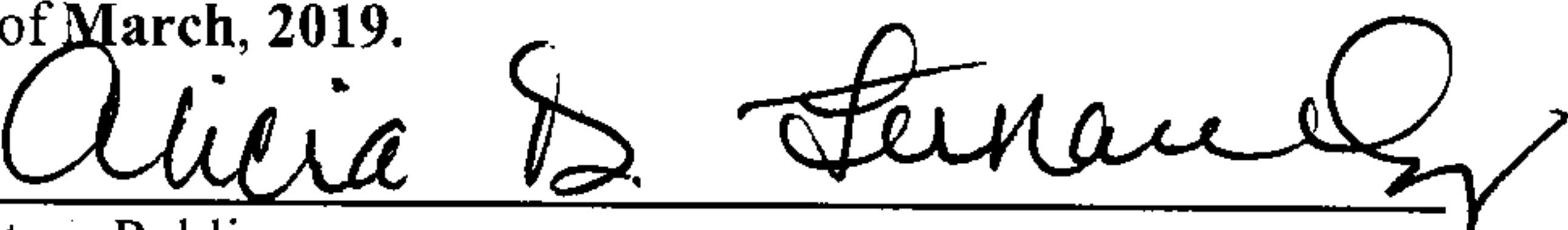
