(herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Gregory B. Moore and Jennifer Moore
(herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **SHELBY** County, Alabama, to-wit:

Lot 17, according to the Final Plat of Waterstone Phase 5, as recorded in Map Book 49, Page 5, in the Probate Office of Shelby County, Alabama.

The purchase of the herein described real property is being financed in whole or in part by the proceeds of purchase money mortgages being executed simultaneously herewith.


