

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 16th day of March, 2007, Jeremy J. Bongo, husband and wife and Lauren M. Bongo, wife and husband, executed that certain mortgage on real property hereinafter described to ABN AMRO Mortgage Group, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070319000124820, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage LLC, by instrument recorded in Instrument Number 20161004000364000, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage, and the said Nationstar Mortgage LLC d/b/a Mr. Cooper did declare all of the indebtedness secured by said mortgage, subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper of general circulation



published in Shelby County, Alabama, in its issues of February 13, 2019, February 20, 2019, and February 27, 2019; and


WHEREAS, on March 5, 2019, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and Nationstar Mortgage LLC d/b/a Mr. Cooper did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, AlaVest, LLC was the highest bidder and best bidder in the amount of One Hundred Twenty-Five Thousand Five Hundred And 00/100 Dollars (\$125,500.00) on the indebtedness secured by said mortgage, the said Nationstar Mortgage LLC d/b/a Mr. Cooper, by and through Sirote & Permutt, P.C., as attorney for said Transferee, does hereby remise, release, quit claim and convey unto AlaVest, LLC all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to-wit:




