WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS: That in consideration of THREE HUNDRED TWENTY THOUSAND AND FIVE HUNDRED DOLLARS AND NO/100 (\$320,500.00), good and valuable consideration, in hand paid by the GRANTEE/S herein, the receipt whereof is acknowledged, we, **LOU MICHAEL CASTILLO and ZURAIDA CASTILLO, husband and wife**, (hereinafter referred to as **GRANTORS**), do hereby, subject to the matters, limitations, and exceptions hereinafter described, GRANT, BARGAIN, SELL, AND CONVEY unto **TIMOTHY ALLEN CAUSEY AND JACQUELINE R. 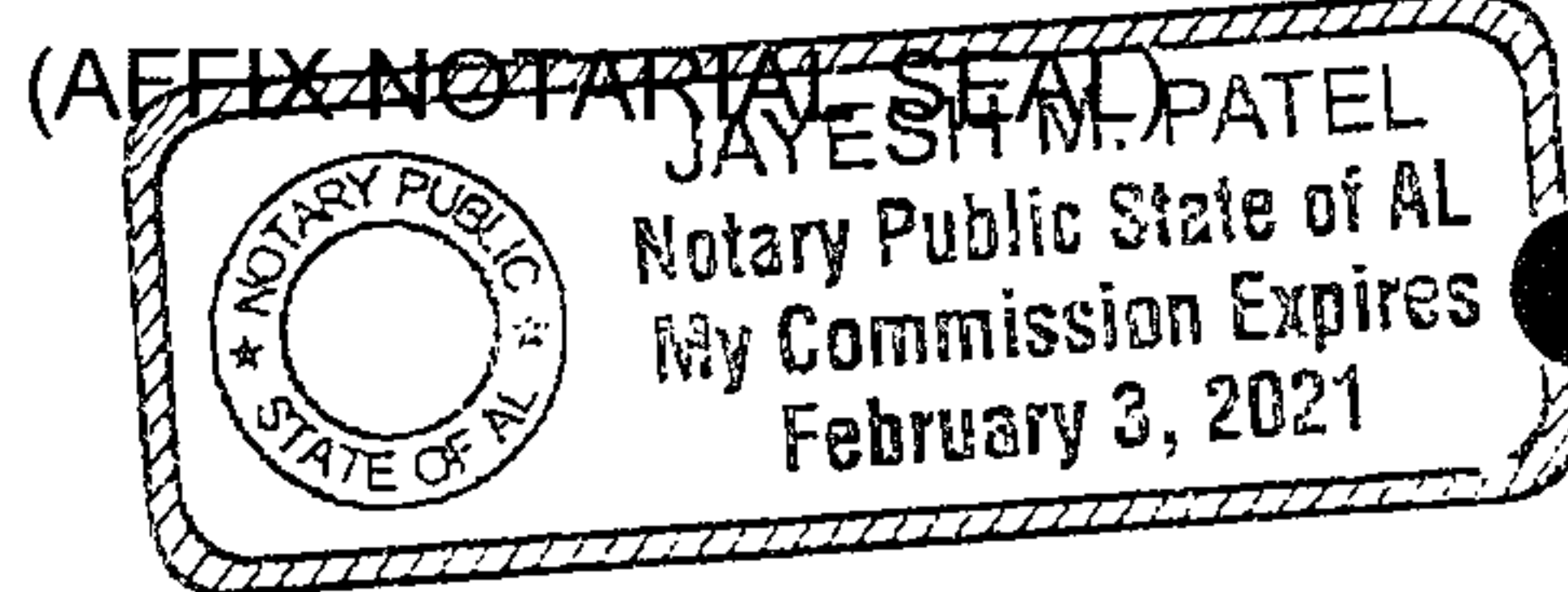

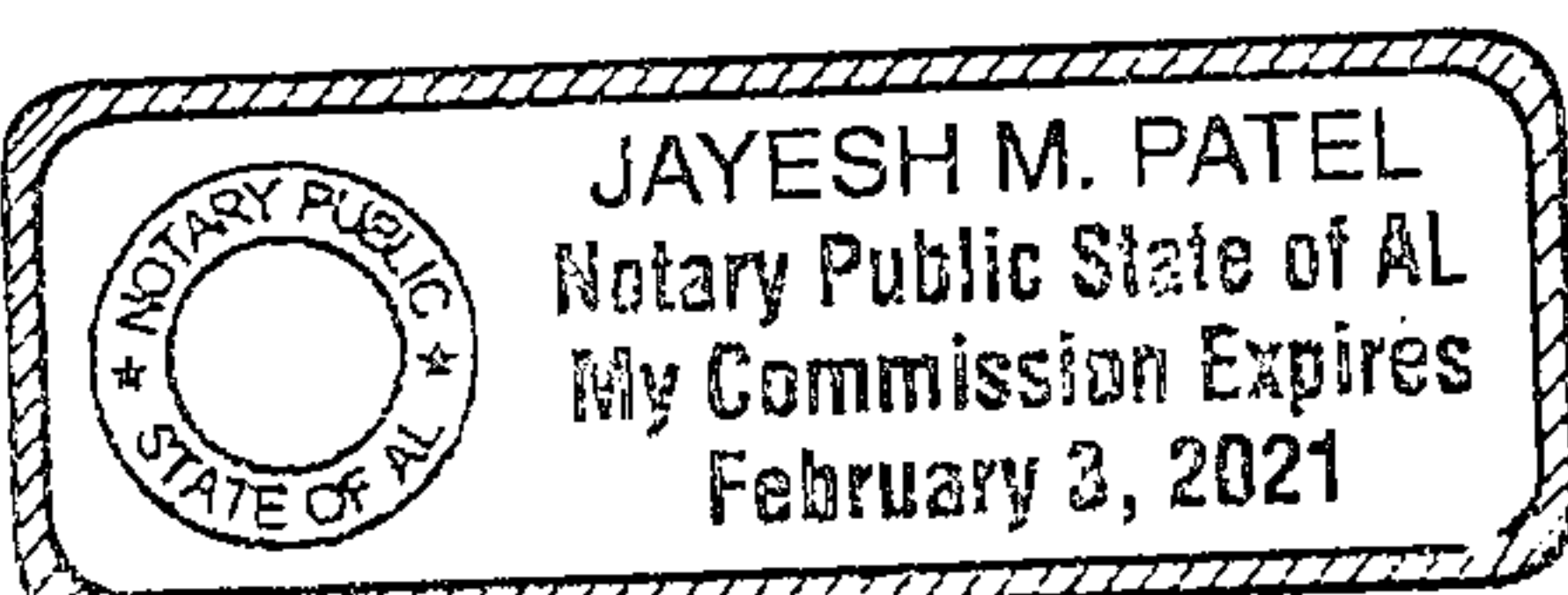

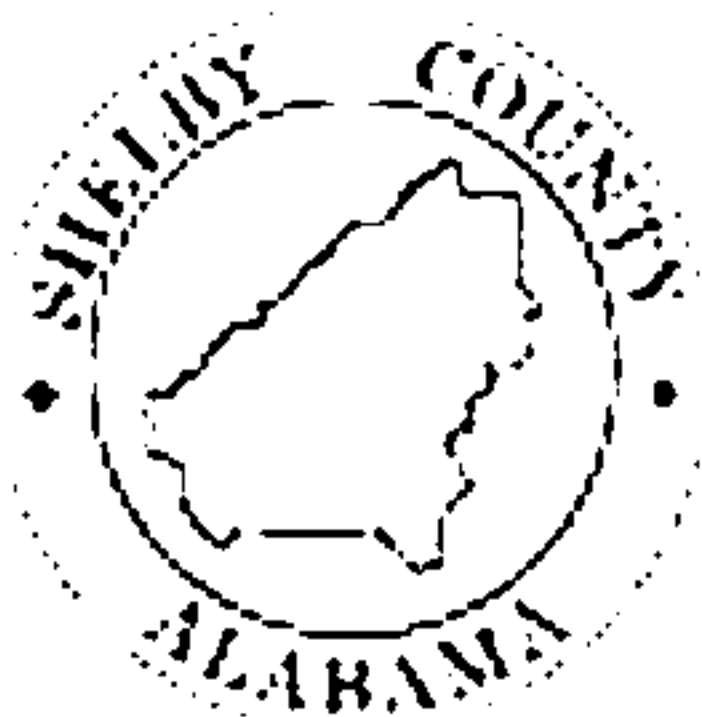
