Ad valorem taxes for 2019 and subsequent years not yet due and payable until October 1, 2019.

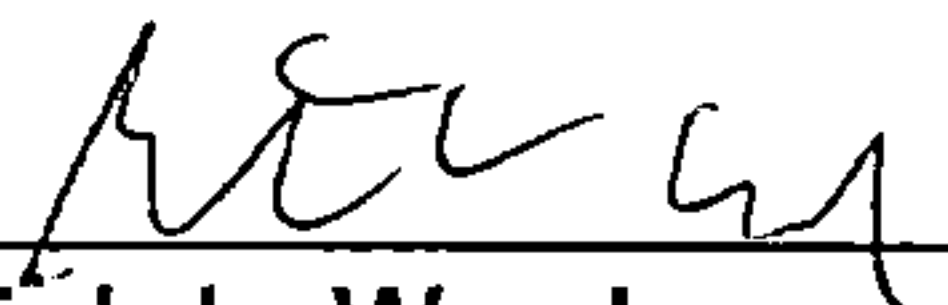
Existing covenants and restrictions, easements, building lines and limitations of record.
