This Power of Attorney shall not be affected by my disability, incompetency or incapacity.

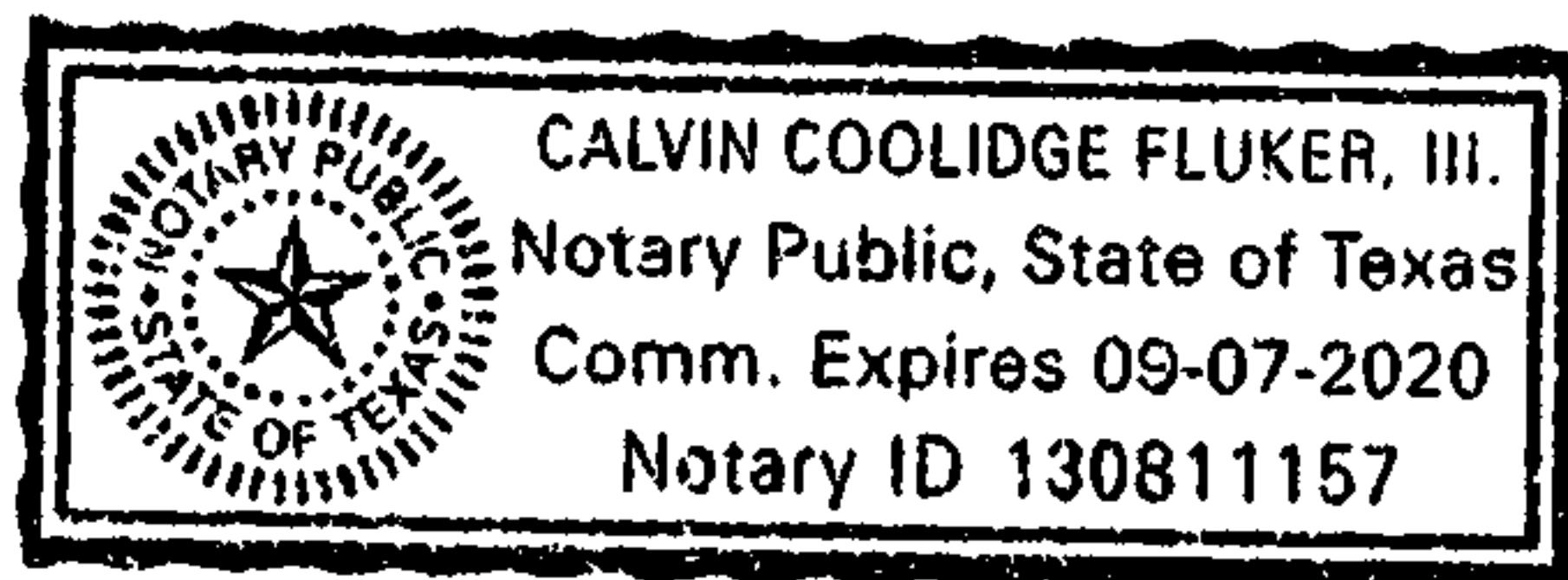
